Practical Law Canada Resource Suggestions on WestlawNext Canada

Now, locating specific Practical Law Canada resources on WestlawNext Canada couldn't be easier.

As a user begins typing in the Global Search Box, Practical Law Canada resource suggestions will appear in the dropdown below.

Practical Law Canada Resource Suggestions

Begin your search using the Global Search Box on WestlawNext Canada. Scroll down in the Search Suggestions drop down to see results from Practical Law Canada.

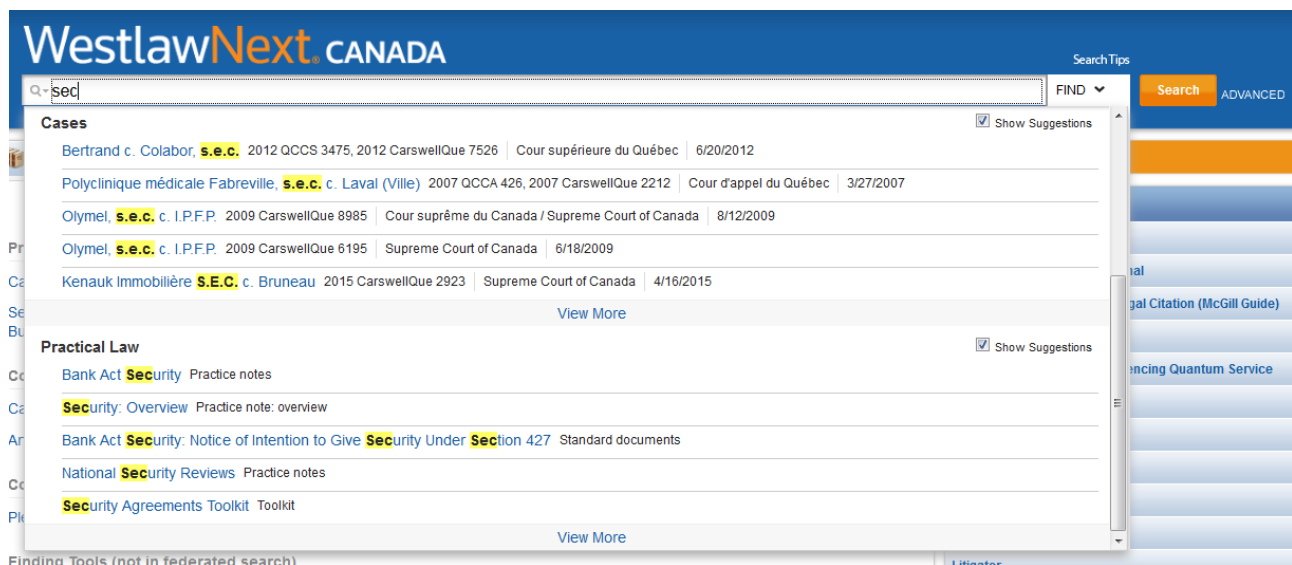


Figure 1: Beginning a search from the home page of WestlawNext Canada

Suggested resources titles appear below the Global Search Box, after the WestlawNext Canada Search and Case suggestions, as you begin typing in your search.

You can then select a resource suggestion by selecting the phrase. The result will open the Practical Law Canada website, in a new tab.

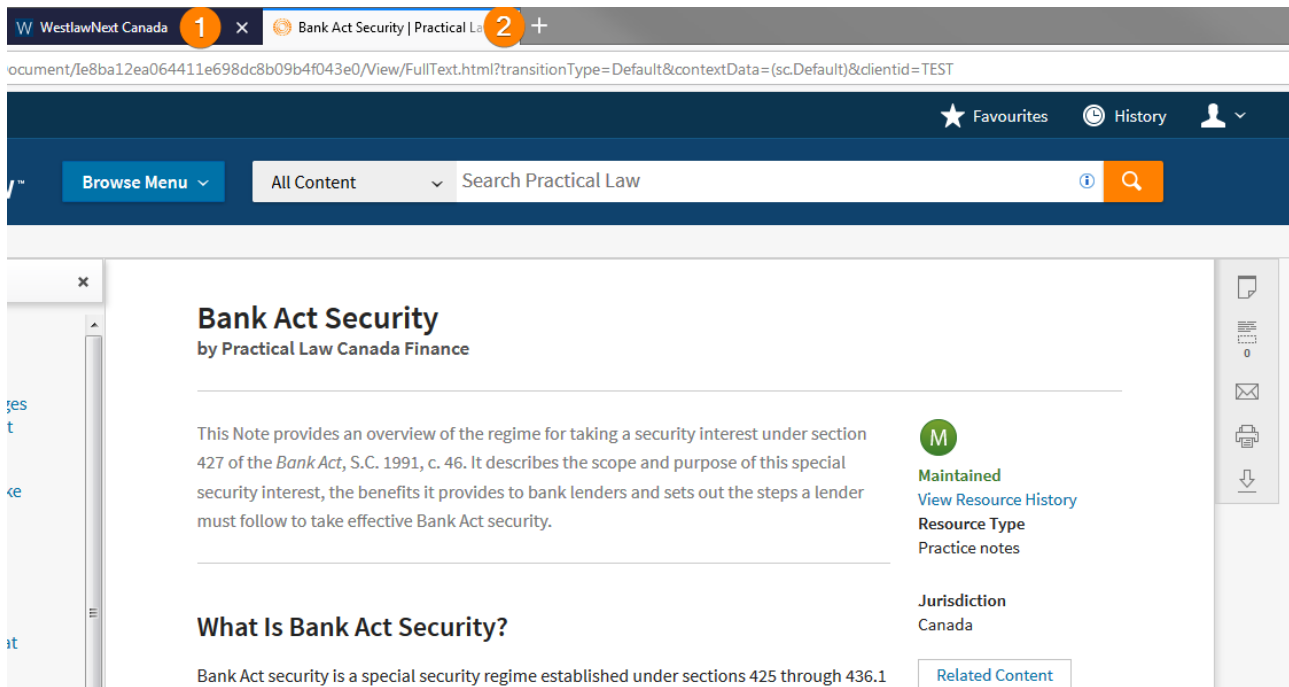


Figure 2: The suggested resource opens in a new Practical Law Canada tab

This provides quicker access to documents, when you are searching for a document by name or for resources which contain a specific term in the document title.

The more search terms you enter, the more refined a suggestion becomes. If you know the exact name of the document you are looking for, it will quickly appear as you enter the first few terms.

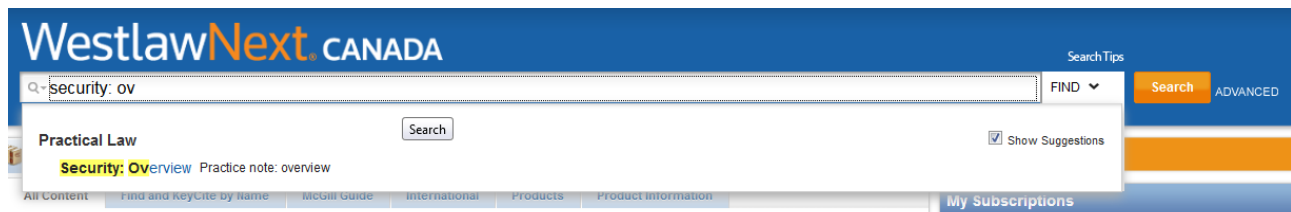


Figure 3: The complete name of a document appears after only a few characters are entered.

Entering terms which do not appear in the title of a document will change the resource suggestions. If a term is included which does not appear in the document title, the resource will no longer be suggested.

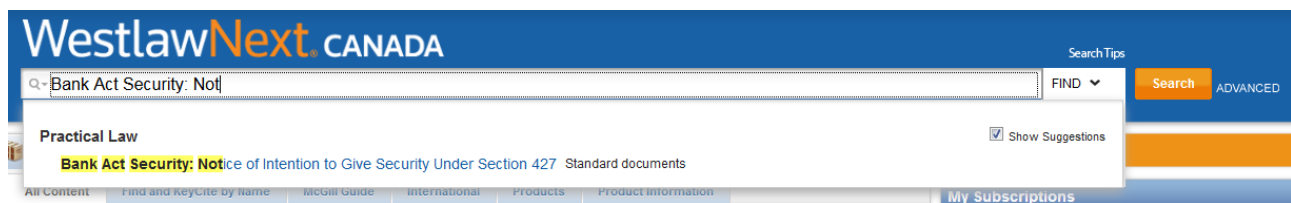


Figure 4: Several terms have been entered, narrowing the results of the suggested resources to just one document.

The Practical Law Canada resources suggested will include Practice Notes, Practice Note Overviews, Standard Documents, Standard Clauses, Checklists, Toolkits, Provincial Q&As, and Legal Updates, as well as French Language documents. Glossary Terms and What's Market Deal Summaries are not included in resources suggestions. The resources suggested are not Practice Area specific, and are listed by relevance to the search terms, rather than Practice Area or document type.

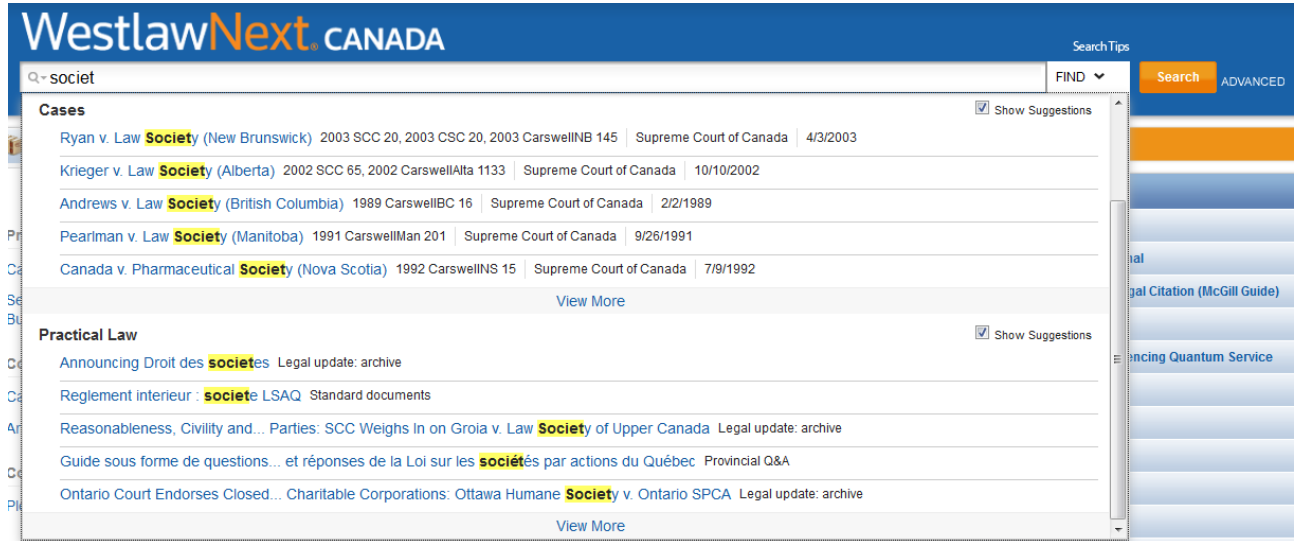
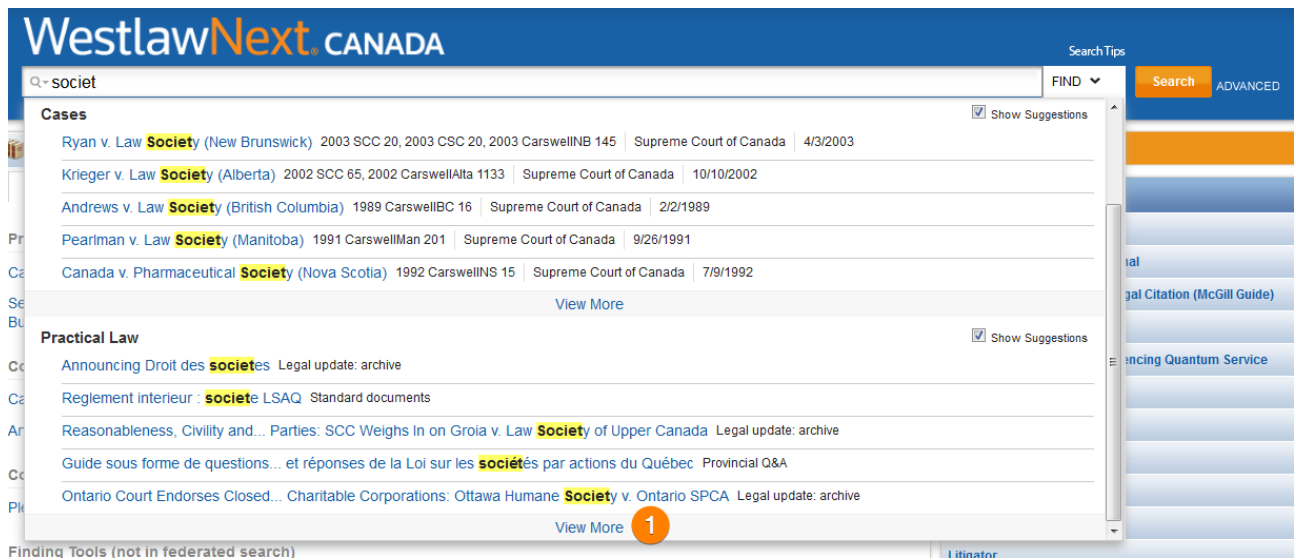


Figure 5: Practical Law Canada suggested resources of various types, including French Language suggestions.

To disable the Practical Law Canada resources suggestions, de-select the check box on the right-hand side of the drop down. This will prevent the suggestions from displaying on a search.

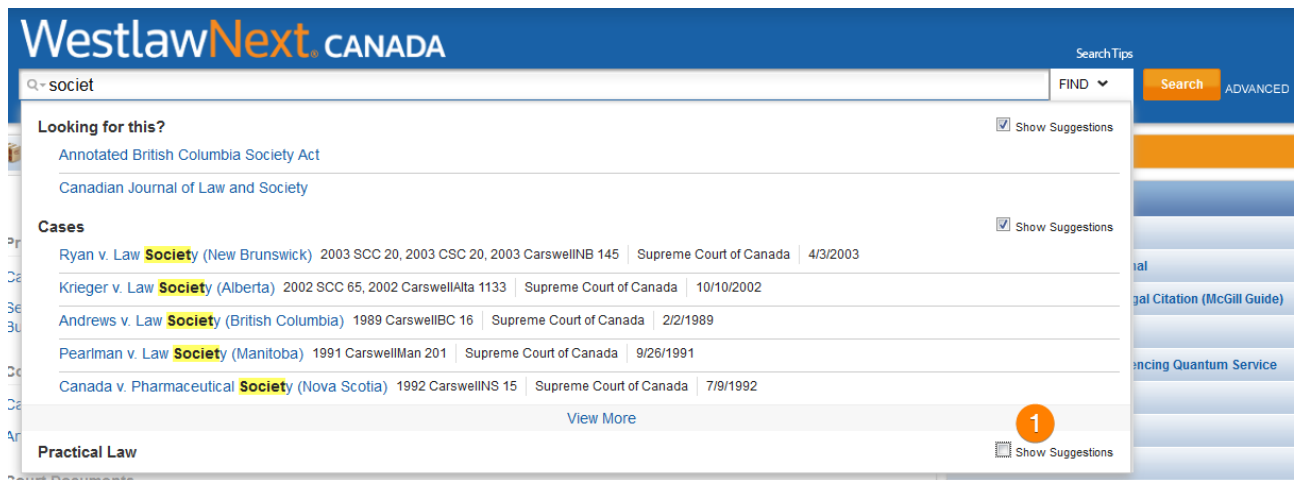


Figure 8: Uncheck "Show Suggestions" from the check box on the right-hand side of the drop-down menu to disable the suggested Practical Law Canada resources.
