## USER'S GUIDE

This service will keep subscribers up-to-date on a weekly basis with the status in both the House of Commons and the Senate of Bills introduced in the current parliamentary session. It is divided into the following four sections:

**NEW THIS WEEK** records the latest stage reached by a Bill during the week's proceedings. The section lists all Bills that in the past week have received either first, second or third reading, been reported from Committee, received Royal Assent, or been brought into force. Because they rarely become law, Private Members' Public Bills are not noted here until they pass second reading. Private

Members' Private Bills are not noted in this Bulletin Service at all. The information in this section is always repeated in the STATUS OF BILLS section.

**STATUS AND SUMMARY OF BILLS** alphabetically lists and reports the status of all Bills that are either currently before Parliament or that have received Royal Assent. A summary of each Bill is provided, where available. The date of coming into force is noted on its occurrence. Bills prefaced by the letter "C" originate in the House of Commons; those prefaced by the letter "S" originate in the Senate. This section is cumulative for the current session.

**CONSEQUENTIAL AMENDMENTS** lists Acts affected by amendments within the copy of the source Bill that has received Royal Assent. The Acts that are amended in consequence will be listed in alphabetical order in this section as soon as we receive the Royal Assent copy of the source Bill. The reader is then referred, in abbreviated format, to the source Bill which contains the amendment. This source Bill will be found in the "STATUS OF BILLS" section, in alphabetical order. This section is cumulative for the current session.

**PROCLAMATIONS and ORDERS IN COUNCIL** lists all Acts passed in a previous session that are brought into force by proclamation or by order in council, in whole or in part, or that are amended by order in council, during the current session. This section is cumulative for the current session.

An Act respecting cyber security, amending the Telecommunications Act and making consequential amendments to other Acts (Bill C-26). Passed Commons. Passed Senate December 5, 2024.

An Act to amend the Criminal Code and the Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act (Bill S-15). Senate reported with amendments December 3, 2024.

First Nations Clean Water Act (Bill C-61). Commons reported with amendments December 2, 2024.

Tax Break for All Canadians Act (Bill C-78). Passed Commons. Senate reported without amendment December 5, 2024.

### Proclamations and Orders in Council

Economic Action Plan 2013 Act, No. 2, S.C. 2013, c. 40 – (SI/2024-60) The day on which this Order is made is fixed as the day on which ss. 263, 266 and 267 of the Act come into force.

First Nations Elections Act, S.C. S.C. 2014, c. 5 – (SOR/2024-225) Item 35 of the schedule to the Act is replaced by the following: 35 Netmizaaggamig Nishnaabeg; Item 41 of the schedule to the Act is replaced by the following: 41 Zagime Anishinabek; Order comes into force on the day on which it is registered.

First Nations Fiscal Management Act, S.C. 2005, c. 9 – (SOR/2024-228) The schedule to the Act is amended by adding the following in alphabetical order: Esk'etemc, Gitanmaax, Mississaugas of the Credit, Poundmaker; Order comes into force on the day on which it is registered – (SOR/2024-227) The schedule to the Act is amended by correcting the names of various band names; Order comes into force on the day on which it is registered.

Indian Act, R.S.C., c. I-5 – (SOR/2024-226) various items under Schedule I, Part I to the Act are replaced; Order in force on the day on which it is registered.

## STATUS AND SUMMARY OF CURRENT BILLS

**(Note: New entries are in bold-face.)**

Affordable Housing and Groceries Act (Bill C-56). Royal Assent December 15, 2023: S.C. 2023, c. 31. Section 8 comes into force on the first anniversary of the day on which this Act receives royal assent. *Summary: Part 1 amends the Excise Tax Act in order to implement a temporary enhancement to the GST New Residential Rental Property Rebate in respect of new purpose-built rental housing. Part 2 amends the Competition Act to, among other things,*

(a) establish a framework for the Minister of Industry to direct the Commissioner of Competition to conduct an inquiry into the state of competition in a market or industry; (b) permit the Competition Tribunal to make certain orders even if none of the parties to an agreement or arrangement – a significant purpose of which is to prevent or lessen competition in any market – are competitors; and (c) repeal the exception in section 96 of the Act involving efficiency gains brought about by mergers.

An Act for the Substantive Equality of Canada's Official Languages (Bill C-13). Royal Assent June 20, 2023; S.C. 2023, c. 15. In force as set out in the Act – (SI/2024-2) January 1, 2024 is fixed as the day on which section 23 of the Act comes into force. *Summary: In Part One the Official Languages Act is amended, it also makes a related amendment to the Department of Canadian Heritage Act. Part 2 enacts the Use of French in Federally Regulated Private Businesses Act, which, among other things, provides for rights and duties respecting the use of French as a language of service and a language of work in relation to federally regulated private businesses in Quebec and then, at a later date, in regions with a strong francophone presence. That Act also allows employees of federally regulated private businesses to make a complaint to the Commissioner of Official Languages with respect to rights and duties in relation to language of work and allows the Commissioner to refer the complaint to the Canada Industrial Relations Board in certain circumstances. It also provides that the Minister of Canadian Heritage is responsible for promoting those rights. Finally, Part 2 makes related amendments to the Canada Labour Code.*

An Act relating to railways (Bill S-1). Senate 1<sup>st</sup> Reading November 23, 2021.

An Act respecting certain measures related to COVID-19 (Bill C-10). Royal Assent March 4, 2022; S.C. 2002, c. 2. In force as set out in the Act. *Summary: This enactment authorizes the Minister of Health to make payments of up to \$2.5 billion out of the Consolidated Revenue Fund in relation to coronavirus disease 2019 (COVID-19) tests. It also authorizes that Minister to transfer COVID-19 tests and instruments used in relation to those tests to the provinces and territories and to bodies and persons in Canada.*

**An Act respecting cyber security, amending the Telecommunications Act and making consequential amendments to other Acts (Bill C-26). Passed Commons. Passed Senate December 5, 2024. *Summary: Part 1 amends the Telecommunications Act to add the promotion of the security of the Canadian telecommunications system as an objective of the Canadian telecommunications policy and to authorize the Governor in Council and the Minister of Industry to direct telecommunications service providers to do anything, or refrain from doing anything, that is necessary to secure the Canadian telecommunications system. It also establishes an administrative monetary penalty scheme to promote compliance with orders and regulations made by the Governor in Council and the Minister of Industry to secure the Canadian telecommunications system as well as rules for judicial review of those orders and regulations. This Part also makes a consequential amendment to the Canada Evidence Act. Part 2 enacts the Critical***

***Cyber Systems Protection Act to provide a framework for the protection of the critical cyber systems of services and systems that are vital to national security or public safety and that are delivered or operated as part of a work, undertaking or business that is within the legislative authority of Parliament. This Part also makes consequential amendments to certain Acts.***

- An Act respecting regulatory modernization (Bill S-6). Passed Senate. Commons 2<sup>nd</sup> Reading June 19, 2024. *Summary: This enactment amends various Acts as part of the Regulatory Modernization Initiative in order to repeal or amend provisions that have, over time, become barriers to innovation and economic growth or to add certain provisions with a view to support innovation and economic growth.*
- An Act respecting the administration of oaths of office (Bill C-1). Commons 1<sup>st</sup> Reading November 23, 2021.
- An Act to amend An Act to amend the Criminal Code (medical assistance in dying) (Bill C-39). Royal Assent March 9, 2023: S.C. 2023, c. 1. In force as set out in the Act. *Summary: This enactment amends An Act to amend the Criminal Code (medical assistance in dying) to delay, until March 17, 2024, the repeal of the exclusion from eligibility for receiving medical assistance in dying in circumstances where the sole underlying medical condition identified in support of the request for medical assistance in dying is a mental illness.*
- An Act to amend certain Acts and to make certain consequential amendments (firearms) (Bill C-21). Royal Assent December 15, 2023: S.C. 2023, c. 32. Sections 5(1) and (2), 9.1, 15, 16, 20, 21.2, 26 to 29, 32 to 36, 38, 40, 41 and 45 come into force on a day or days to be fixed by order of the Governor in Council. Sections 3(2) and 13(1.1) come into force on the 30th day after the day on which this Act receives royal assent. Sections 49 to 51 come into force on a day to be fixed by order of the Governor in Council – (SI/2024-27) September 1, 2024 is fixed as the day on which ss. 0.1(1), 0.2(1), 1(3, 5), 1.1(1, 2), 1.2(1, 2), 1.3(1), 1.5(1, 2), 1.6(1), 4(2, 3), 5(1, 9), 10(2), 10.1(1), 11.1(1), 11.2(1), 11.3(1, 2), 12(1), 12.1(1), 12.2(1), 12.3(1), 13.1(1), 13.2(1), 13.3(1, 2), 13.4(1), 13.5(1), 13.6(1), 13.7(1), 13.8(1), 13.9(1), 13.10(1), 13.11(1) and 13.12(1) of the Act come into force. September 1, 2024 is fixed as the day on which ss. 3.1(1-3) and 3.2(1) of the English version of the Act come into force. September 1, 2024 is fixed as the day on which ss. 3.1(1-4) and 3.2(1, 2) of the French version of that Act come into force – (SI/2024-28) September 1, 2024 is fixed as the day on which ss. 21.2, 26 and 45 of the Act come into force – (SI/2024-42) October 1, 2024 is fixed as the day on which ss. 20, 27 to 29, 32, 22, 35(1) of the Act come into force. *Summary: This Act amends various other Acts.*
- An Act to amend the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act and the Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Act and to make consequential amendments to other Acts (Bill C-49). Royal Assent October 3, 2024: S.C. 2024, c. 20. In force as set out in the Act. *Summary: This enactment amends the Canada-Newfound-*

*land and Labrador Atlantic Accord Implementation Act and the Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Act and it makes consequential and terminological amendments to other Acts.*

An Act to amend the Canada Business Corporations Act and to make consequential and related amendments to other Acts (Bill C-42). Royal Assent November 1, 2023: S.C. 2023, c. 29. Act, other than section 20, comes into force on a day or days to be fixed by order of the Governor in Council, but that day or those days must not be before the day on which section 1 comes into force. Sections 1 and 19 come into force on a day or days to be fixed by order of the Governor in Council; sections 2, 4 to 6 and 17 come into force on a day to be fixed by order of the Governor in Council, but that day must not be before the day on which section 431 of the Budget Implementation Act, 2022, No. 1 comes into force. January 22, 2024 is fixed as the day on which sections 1 to 19 of the Act come into force. *Summary: This enactment amends the Canada Business Corporations Act to, among other things, (a) require the Director appointed under that Act to make available to the public certain information on individuals with significant control over a corporation; (b) protect the information and identity of certain individuals; (c) add, or broaden the application of, offences and provide the Director with additional enforcement and compliance powers; and (d) add regulatory authority to prescribe further requirements in certain provisions. It also makes consequential and related amendments to other Acts.*

An Act to amend the Canada Labour Code and the Canada Industrial Relations Board Regulations, 2012 (Bill C-58). Royal Assent June 13, 2024: S.C. 2024, c. 12. Act comes into force on the day that, in the 12th month after the month in which it receives royal assent, has the same calendar number as the day on which it receives royal assent or, if that 12th month has no day with that number, the last day of that 12th month. *Summary: This enactment amends the Canada Labour Code to, among other things, (a) amend the scope of the prohibition relating to replacement workers by removing the requirement of demonstrating a purpose of undermining a trade union's representational capacity, by adding persons whose services must not be used during legal strikes and lockouts and by providing certain exceptions; (b) prohibit employers from using, during a legal strike or lockout intended to involve the cessation of work by all employees in a bargaining unit, the services of an employee in that unit, subject to certain exceptions; (c) make the contravention by employers of either of those prohibitions an offence punishable by a fine of up to \$100,000 per day; (d) authorize the Governor in Council to make regulations establishing an administrative monetary penalties scheme for the purpose of promoting compliance with those prohibitions; and (e) amend the maintenance of activities process in order to, among other things, encourage employers and trade unions to reach an earlier agreement respecting activities to be maintained in the event of a legal strike or lockout, encourage faster decision making by the Canada Industrial Relations Board when parties are unable to agree and reduce the need for the Minister of Labour to make referrals to the Board.*

- An Act to amend the Canada National Parks Act (Bill C-76). Royal Assent October 3, 2024: S.C. 2024, c. 21. In force as set out in the act. *Summary: This enactment amends the Canada National Parks Act to (a) allow a local government body to exercise powers in relation to land use planning and development in the town of Jasper as provided in an agreement applicable to that town; and (b) provide that certain regulations do not apply to the town of Jasper once a municipal by-law applicable to that town respecting land use planning and development comes into force.*
- An Act to amend the Canada National Parks Act (Ojibway National Urban Park of Canada) (Bill C-248). Passed Commons. Senate 2<sup>nd</sup> Reading April 17, 2024. *Summary: This enactment amends the Canada National Parks Act to establish Ojibway National Urban Park of Canada.*
- An Act to amend the Canadian Environmental Protection Act, 1999 (final disposal of plastic waste) (Bill S-234). Senate 2<sup>nd</sup> Reading June 8, 2023. *Summary: This enactment amends the Canadian Environmental Protection Act, 1999 to prohibit the export of certain types of plastic waste to foreign countries for final disposal.*
- An Act to amend the Chemical Weapons Convention Implementation Act (Bill S-9). Royal Assent June 19, 2024: S.C. 2024, c. 14. In force as set out in the Act. *Summary: This enactment amends the Chemical Weapons Convention Implementation Act by deleting the schedule to that Act and the references to that schedule in that Act, in order to avoid potential discrepancies between the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on their Destruction, as amended from time to time, and the portions of that Convention that are reproduced in that schedule.*
- An Act to amend the Citizenship Act and the Immigration and Refugee Protection Act (Bill S-235). Passed Senate. Commons 1<sup>st</sup> Reading October 23, 2024. *Summary: This enactment amends the Citizenship Act to provide citizenship for certain persons when they transition out of the care of a child welfare agency or foster parent. It also amends the Immigration and Refugee Protection Act to provide that, in certain circumstances, a removal order cannot be enforced against a person who was not a citizen when they transitioned out of such care.*
- An Act to amend the Citizenship Act (granting citizenship to certain Canadians) (Bill S-245). Passed Senate. Commons reported with amendments June 12, 2023. *Summary: This enactment amends the Citizenship Act to permit certain persons who lost their Canadian citizenship to regain it.*
- An Act to amend the Citizenship Act (2024) (C-71). Commons 1<sup>st</sup> Reading May 23, 2024. *Summary: This enactment amends the Citizenship Act to, among other things, (a) ensure that citizenship by descent is conferred on all persons who were born outside Canada before the coming into force of this enactment to a parent who was a citizen; (b) confer citizenship by descent on persons born outside Canada after the first generation, on or after the coming into force of this enactment, to a parent who is a citizen and who had a substantial connection to Canada before the Person's birth; (c) allow citizenship*

to be granted under section 5.1 of that Act to all persons born outside Canada who were adopted before the coming into force of this enactment by a parent who was a citizen; (d) allow citizenship to be granted under section 5.1 of that Act to persons born outside Canada who are adopted on or after the coming into force of this enactment by a parent who is a citizen and who had a substantial connection to Canada before the person's adoption; (e) restore citizenship to persons who lost their citizenship because they did not make an application to retain it under the former section 8 of that Act or because they made an application under that section that was not approved; and (f) allow certain persons who become citizens as a result of the coming into force of this enactment to access a simplified process to renounce their citizenship.

An Act to amend the Copyright Act (diagnosis, maintenance and repair) (Bill C-244). Royal Assent November 7, 2024: S.C. 2024, c. 26. In force as set out in the Act. *Summary: This enactment amends the Copyright Act in order to allow the circumvention of a technological protection measure in a computer program if the circumvention is solely for the purpose of the diagnosis, maintenance or repair of a product in which the program is embedded. It also allows the manufacture, importation, distribution, sale, renting and provision of technologies, devices or components used for the diagnosis, maintenance or repair of such products.*

An Act to amend the Copyright Act (interoperability) (Bill C-294). Royal Assent November 7, 2024: S.C. 2024, c. 27. In force as set out in the Act. *Summary: This enactment amends the Copyright Act to allow a person, in certain circumstances, to circumvent a technological protection measure to make a computer program interoperable with any device or component, or with a product they manufacture.*

An Act to amend the Criminal Code and the Canada Labour Code (Bill C-3). Passed Commons. Senate 1<sup>st</sup> Reading December 16, 2021. *Summary: This enactment amends the Criminal Code to, among other things, (a) create an offence of intimidating a person in order to impede them from obtaining health services, intimidating a health professional in order to impede them in the performance of their duties or intimidating a person who assists a health professional in order to impede the person in providing that assistance; (b) create an offence of obstructing or interfering with a person's lawful access to a place at which health services are provided, subject to a defence of attending at the place for the purpose only of obtaining or communicating information; and (c) add the commission of an offence against a person who was providing health services and the commission of an offence that had the effect of impeding another person from obtaining health services as aggravating sentencing factors for any offence. It also amends the Canada Labour Code to, among other things, (a) repeal the personal leave that an employee may take to treat their illness or injury; (b) provide that an employee may earn and take up to 10 days of medical leave of absence with pay in a calendar year; and (c) authorize the Governor in Council to make regulations to*



*modify, in certain circumstances, the provisions respecting medical leave of absence with pay.*

An Act to amend the Criminal Code and the Controlled Drugs and Substances Act (Bill C-5). Royal Assent November 17, 2022: S.C. 2022, c. 15. In force as set out in the Act. *Summary: This enactment amends the Criminal Code and the Controlled Drugs and Substances Act to, among other things, repeal certain mandatory minimum penalties, allow for a greater use of conditional sentences and establish diversion measures for simple drug possession offences.*

An Act to amend the Criminal Code and the Identification of Criminals Act and to make related amendments to other Acts (COVID-19 response and other measures) (Bill S-4). Royal Assent December 15, 2022: S.C. 2022, c. 17. The Act comes into force on the 30th day after the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code to, among other things, (a) allow for the use of electronic or other automated means for the purposes of the jury selection process; (b) expand, for the accused and offenders, the availability of remote appearances by audioconference and videoconference in certain circumstances; (c) provide for the participation of prospective jurors in the jury selection process by videoconference in certain circumstances; (d) expand the power of courts to make case management rules permitting court personnel to deal with administrative matters for accused not represented by counsel; (e) permit courts to order fingerprinting at the interim release stage and at any other stage of the criminal justice process if fingerprints could not previously have been taken for exceptional reasons; and (f) replace the existing telewarrant provisions with a process that permits a wide variety of search warrants, authorizations and orders to be applied for and issued by a means of telecommunication. The enactment makes amendments to the Criminal Code and the Identification of Criminals Act to correct minor technical errors and includes transitional provisions on the application of the amendments. It also makes related amendments to other Acts.*

An Act to amend the Criminal Code and the Immigration and Refugee Protection Act (trafficking in human organs) (Bill S-223). Royal Assent December 15, 2022: S.C. 2022, c. 18. In force as set out in the Act. *Summary: This enactment amends the Criminal Code to create new offences in relation to trafficking in human organs. It also amends the Immigration and Refugee Protection Act to provide that a permanent resident or foreign national is inadmissible to Canada if the appropriate minister is of the opinion that they have engaged in any activities relating to trafficking in human organs.*

An Act to amend the Criminal Code and the Indian Act (Bill S-268). Senate 2<sup>nd</sup> Reading May 30, 2024. *Summary: This enactment amends section 207 the Criminal Code to provide that the governing body of a First Nation has exclusive authority to conduct and manage a lottery scheme on its reserve and to license the conduct and management of a lottery scheme by other persons and entities on its reserve, if the governing body of the First Nation has provided notice to the Government of Canada and the government of any prov-*

*ince in which the reserve is located of its intention to exercise that authority. This enactment also amends the Indian Act to grant the council of the band authority to make by-laws for the purposes of regulating the operation, conduct and management of lottery schemes permitted on the band's reserve under section 207 of the Criminal Code.*

An Act to amend the Criminal Code and the Judges Act (violence against an intimate partner) (Bill C-233). Royal Assent April 27, 2023: S.C. 2023, c. 7. Act comes into force on the 30th day after the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code to require a justice, before making a release order in respect of an accused who is charged with an offence against their intimate partner, to consider whether it is desirable, in the interests of the safety and security of any person, to include as a condition of the order that the accused wear an electronic monitoring device. The enactment also amends the Judges Act to provide for continuing education seminars for judges on matters related to intimate partner violence and coercive control.*

**An Act to amend the Criminal Code and the Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act (Bill S-15). Senate reported with amendments December 3, 2024. *Summary: This enactment amends the Criminal Code to create offences related to keeping elephants and great apes in captivity, subject to certain exceptions. It also amends the Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act to, among other things, specify the circumstances in which the importation or exportation of living elephants and great apes may be permitted as well as the circumstances in which the keeping of these animals in captivity may be authorized.***

An Act to amend the Criminal Code and to make consequential amendments to other Acts (Bill C-41). Royal Assent June 20, 2023: S.C. 2023, c. 14. In force as set out in the Act. *Summary: This enactment amends the Criminal Code in order to create a regime under which the Minister of Public Safety and Emergency Preparedness may authorize an eligible person to carry out, in a geographic area that is controlled by a terrorist group and for certain purposes, activities that otherwise would be prohibited under paragraph 83.03(b) of that Act (which becomes subsection 83.03(2)). It also makes consequential amendments to other Acts.*

An Act to amend the Criminal Code and to make consequential amendments to other Acts (child sexual abuse material) (Bill C-291). Royal Assent October 10, 2024: S.C. 2024, c. 23. Act comes into force on the first anniversary of the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code to replace the term 'child pornography' with 'child sexual abuse material' and makes consequential amendments to other Acts.*

An Act to amend the Criminal Code and to make consequential amendments to another Acts (interim release and domestic violence recognizance orders) (Bill S-205). Royal Assent October 10, 2024: S.C. 2024, c. 22. Act comes into force 180 days after the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code in respect of interim release and*

*other orders related to intimate partner violence offences. The enactment also provides for recognizance orders to be made when there is a reasonable fear of domestic violence.*

- An Act to amend the Criminal Code (bail reform) (Bill C-48). Royal Assent December 5, 2023: S.C. 2023, c. 30. Act comes into force on the 30th day after the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code to, among other things, (a) create a reverse onus provision for any person charged with a serious offence involving violence and the use of a weapon who has been convicted, within the last five years, of a serious offence involving violence and the use of a weapon; (b) add certain firearms offences to the existing reverse onus provisions; (c) expand the reverse onus provision for offences involving intimate partner violence to ensure that it applies to an accused person who has been previously discharged for such an offence; and (d) require the court to consider if an accused person has any previous convictions involving violence and to include in the record a statement that the safety and security of the community was considered. This enactment also makes further clarifications and provides for a parliamentary review of the provisions it enacts or amends to commence on the fifth anniversary of the day on which it receives royal assent, or as soon as feasible after that anniversary.*
- An Act to amend the Criminal Code (conversion therapy) (Bill C-4). Royal Assent December 8, 2021: S.C. 2021, c. 24. Act comes into force on the 30th day after the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code to, among other things, create the following offences: (a) causing another person to undergo conversion therapy; (b) doing anything for the purpose of removing a child from Canada with the intention that the child undergo conversion therapy outside Canada; (c) promoting or advertising conversion therapy; and (d) receiving a financial or other material benefit from the provision of conversion therapy. It also amends the Criminal Code to authorize courts to order that advertisements for conversion therapy be disposed of or deleted.*
- An Act to amend the Criminal Code (Corinne's Quest and the protection of children) (Bill C-273). Commons reported with an amendment May 8, 2024. *Summary: This enactment amends the Criminal Code to repeal a provision that authorizes the correction of a child by force if certain criteria are met.*
- An Act to amend the Criminal Code (disclosure of information by jurors) (Bill S-206). Royal Assent October 18, 2022: S.C. 2022, c. 12. The Act comes into force on the 90th day after the day on which it receives royal assent. *Summary: This enactment amends the Criminal Code to provide that the prohibition against the disclosure of information relating to jury proceedings does not apply, in certain circumstances, in respect of disclosure by jurors to health care professionals.*
- An Act to amend the Criminal Code (independence of the judiciary) (Bill S-213). Senate 2<sup>nd</sup> Reading April 26, 2022. *Summary: This enactment amends the Criminal Code to give a court the discretion to vary the punishment to be imposed in respect of an offence for which the punishment – or different de-*

*grees or kinds of punishment – is prescribed in an enactment. It allows a court to decide to not make a mandatory prohibition order provided for under a provision of that Act – or to add conditions or vary any of the conditions set out in that provision – if the court considers it just and reasonable to do so. It requires the court to provide its reasons for making such a decision. It requires a court to consider all available options prior to imposing a minimum punishment of imprisonment or period of parole ineligibility under a provision of any Act of Parliament, and to provide written reasons for imposing a minimum punishment of imprisonment or period of parole ineligibility. It gives a court discretion in the treatment or counselling program that a person who has been found guilty of an offence may attend and removes the requirement for the Attorney General to give his or her consent in order to delay sentencing under subsection 720(2) of that Act. It provides that a judge is to take into consideration the recommendation of the jury in setting the period of parole ineligibility for a person who has been found guilty of first or second degree murder.*

- An Act to amend the Criminal Code (medical assistance in dying) (Bill S-248). Senate 2<sup>nd</sup> Reading June 8, 2023. *Summary: This enactment amends the Criminal Code to (a) permit an individual whose death is not reasonably foreseeable to enter into a written arrangement to receive medical assistance in dying on a specified day if they lose the capacity to consent to receiving medical assistance in dying prior to that day; and (b) permit an individual who has been diagnosed with a serious and incurable illness, disease or disability to make a written declaration to waive the requirement for final consent when receiving medical assistance in dying if they lose the capacity to consent to receive medical assistance in dying, are suffering from symptoms outlined in the written declaration and have met all other relevant safeguards outlined in the Criminal Code.*
- An Act to amend the Criminal Code (medical assistance in dying) (Bill S-248). Senate 2<sup>nd</sup> Reading June 8, 2023. *Summary: This enactment amends the Criminal Code to (a) permit an individual whose death is not reasonably foreseeable to enter into a written arrangement to receive medical assistance in dying on a specified day if they lose the capacity to consent to receiving medical assistance in dying prior to that day; and (b) permit an individual who has been diagnosed with a serious and incurable illness, disease or disability to make a written declaration to waive the requirement for final consent when receiving medical assistance in dying if they lose the capacity to consent to receive medical assistance in dying, are suffering from symptoms outlined in the written declaration and have met all other relevant safeguards outlined in the Criminal Code.*
- An Act to amend An Act to amend the Criminal Code (medical assistance in dying), No. 2 (Bill C-62). Passed Commons. Senate 1<sup>st</sup> Reading February 15, 2024. *Summary: This enactment amends An Act to amend the Criminal Code (medical assistance in dying) to provide that persons are not eligible, until March 17, 2027, to receive medical assistance in dying if their sole underlying medical condition is a mental illness.*

- An Act to amend the Criminal Code (self-induced extreme intoxication) (Bill C-28). Royal Assent June 23, 2022: S.C. 2022, c. 11. *Summary: This enactment amends the Criminal Code to provide for criminal liability for violent crimes of general intent committed by a person while in a state of negligent self-induced extreme intoxication.*
- An Act to amend the Criminal Code (sterilization procedures) (Bill S-250). Passed Senate October 8, 2024. *Summary: This enactment amends the Criminal Code to establish an offence with respect to sterilization procedures.*
- An Act to amend the Criminal Code, the Sex Offender Information Registration Act and the International Transfer of Offenders Act (Bill S-12). Royal Assent October 26, 2023: S.C. 2023, c. 28. In force as set out in the Act. *Summary: This enactment amends the Criminal Code, the Sex Offender Information Registration Act and the International Transfer of Offenders Act to, among other things, (a) require compliance with the Sex Offender Information Registration Act for persons who are convicted of an offence of a sexual nature against a child and for persons who have been convicted on separate occasions of two or more offences of a sexual nature; (b) require other persons who are convicted of, or receive a verdict of not criminally responsible on account of mental disorder for, an offence of a sexual nature to comply with that Act unless a court is satisfied that doing so would have no connection to the purposes of that Act or that the impact on the person of doing so would be grossly disproportionate to those purposes; (c) provide that an order to comply with that Act as a result of convictions, or verdicts of not criminally responsible on account of mental disorder, for two or more offences of a sexual nature that are dealt with in the same proceeding – or an obligation to comply with that Act as a result of convictions, or such verdicts, for two or more offences of a sexual nature – does not apply for life if a court is satisfied that the offences do not demonstrate a pattern of behaviour showing that the person presents an increased risk of reoffending by committing such an offence; (d) authorize a peace officer to obtain a warrant to arrest a person who has contravened any of sections 4 to 5.1 of that Act and bring them to a registration centre to remedy that contravention; and (e) clarify the obligations in section 6 of that Act respecting the notice that sex offenders who plan to absent themselves from their residence must provide. The enactment also amends the Criminal Code to, among other things, codify the process for modifying and revoking publication bans, and add a requirement for sentencing courts to inquire into whether the victim of an offence would like to receive information about the administration of the offender’s sentence and, in the affirmative, provide the Correctional Service of Canada with the victim’s contact information.*
- An Act to amend the Criminal Code (trafficking in persons) (Bill S-224). Passed Senate. Commons reported with amendments September 20, 2023. *Summary: This enactment amends the Criminal Code to specify what constitutes exploitation for the purpose of establishing whether a person has committed the offence of trafficking in persons.*

- An Act to amend the Criminal Records Act, to make consequential amendments to other Acts and to repeal a regulation (Bill S-212). Senate reported with amendments September 26, 2023. *Summary: This enactment amends the Criminal Records Act to provide for the expiry of criminal records. It also makes consequential amendments to other Acts and repeals a regulation.*
- An Act to amend the Customs Act and the Preclearance Act, 2016 (Bill S-7). Passed Senate. Commons 1<sup>st</sup> Reading October 20, 2022. *Summary: This enactment amends the Customs Act to (a) clarify the circumstances in which border service officers may examine documents stored on personal digital devices; (b) authorize the making of regulations in respect of those examinations; and (c) update certain provisions respecting enforcement, offences and punishment. The enactment also amends the Preclearance Act, 2016 to (a) clarify the circumstances in which preclearance officers may examine, search and detain documents stored on personal digital devices; (b) authorize the making of regulations and the giving of ministerial directions in respect of those examinations, searches and detentions; and (c) update the French version of that Act in respect of a traveller's obligation to identify themselves.*
- An Act to amend the Department of Employment and Social Development Act and the Employment Insurance Act (Employment Insurance Council) (Bill S-244). Passed Senate. Commons 1<sup>st</sup> Reading September 23, 2024. *Summary: This enactment amends the Department of Employment and Social Development Act to establish the Employment Insurance Council. It also amends the Employment Insurance Act in respect of the Council.*
- An Act to amend the Department of Employment and Social Development Act and to make consequential amendments to other Acts (Employment Insurance Board of Appeal) (Bill C-37). Commons 1<sup>st</sup> Reading December 14, 2022. *Summary: This enactment amends the Department of Employment and Social Development Act to, among other things, (a) establish the Employment Insurance Board of Appeal to hear appeals of decisions made under the Employment Insurance Act instead of the Employment Insurance Section of the General Division of the Social Security Tribunal; and (b) eliminate the requirement for leave to appeal decisions relating to the Employment Insurance Act to the Appeal Division of the Tribunal. It also makes consequential amendments to other Acts.*
- An Act to amend the Department of Foreign Affairs, Trade and Development Act (supply management) (Bill C-282). Passed Commons. Senate reported with amendment November 7, 2024. *Summary: This enactment amends the Department of Foreign Affairs, Trade and Development Act so that the Minister of Foreign Affairs cannot make certain commitments with respect to international trade regarding certain goods.*
- An Act to amend the Department of Public Works and Government Services Act (use of wood) (Bill S-222). Royal Assent October 26, 2023: S.C. 2023, c. 27. In force as set out in the Act. *Summary: This enactment amends the Department of Public Works and Government Services Act to permit the Minister, in developing requirements for public works, to allow the use of wood or any other thing that achieves environmental benefits.*

- An Act to amend the Employment Insurance Act and the Employment Insurance Regulations (Prince Edward Island) (Bill S-236). Senate reported with amendments June 23, 2022. *Summary: This enactment amends the Employment Insurance Act and the Employment Insurance Regulations to provide that Prince Edward Island is one region for the purpose of applying Parts I and VIII of the Act.*
- An Act to amend the Employment Insurance Act (illness, injury or quarantine) (Bill C-215). Commons reported without amendment October 25, 2022. *Summary: This enactment amends the Employment Insurance Act to increase from 15 to 52 the maximum number of weeks for which benefits may be paid because of illness, injury or quarantine.*
- An Act to amend the Federal-Provincial Fiscal Arrangements Act and the Income Tax Act (Bill C-46). Royal Assent May 11, 2023: S.C. 2023, c. 11. In force as set out in the Act. *Summary: This enactment amends the Federal-Provincial Fiscal Arrangements Act to authorize additional payments to the provinces and territories. It also amends the Income Tax Act to provide an additional payment of the Goods and Services Tax/Harmonized Sales Tax (GST/HST) credit equal to double the amount of the regular January 2023 payment.*
- An Act to amend the Federal-Provincial Fiscal Arrangements Act and to authorize certain payments to be made out of the Consolidated Revenue Fund (Bill C-17). Commons 1<sup>st</sup> Reading March 25, 2022. *Summary: This enactment amends the Federal-Provincial Fiscal Arrangements Act to authorize additional payments to the provinces and territories. It also authorizes payments to be made out of the Consolidated Revenue Fund for the purpose of addressing transit shortfalls and needs and improving housing supply and affordability.*
- An Act to amend the First Nations Fiscal Management Act, to make consequential amendments to other Acts, and to make a clarification relating to another Act (Bill C-45). Royal Assent June 20, 2023: S.C. 2023, c. 16. Sections 3(1), (3) and (5), 4, 5(2) and (4), 6, 9, 15, 24 to 26, 27(1), (2) and (4) to (7), 28 to 30, 32, 33, 35(3), 36, 38(2), 40(1) and (3), 41, 42, 51, 52(2) and 57 come into force on a day or days to be fixed by order of the Governor in Council. *Summary: This enactment amends the First Nations Fiscal Management Act to expand and modernize the mandates of the First Nations Tax Commission and the First Nations Financial Management Board in order to better reflect their current and future activities. The enactment also establishes a First Nations Infrastructure Institute that will provide First Nations and other interested Indigenous groups and organizations with tools and support, including with respect to best practices, to implement and manage their infrastructure. It also provides First Nations named in the schedule to the First Nations Fiscal Management Act with the power to make laws to regulate services provided by or on behalf of the First Nations. Finally, the enactment makes consequential amendments to the Access to Information Act and to the Privacy Act and includes a clarification that addresses a transitional administrative oversight that followed the establishment in 2019 of the Department of*

*Crown-Indigenous Relations and Northern Affairs and the Department of Indigenous Services.*

- An Act to amend the Food and Drugs Act (warning label on alcoholic beverages) (Bill S-254). Senate 2<sup>nd</sup> Reading June 1, 2023. *Summary: This enactment amends the Food and Drugs Act to require a warning label on alcoholic beverages.*
- An Act to amend the Greenhouse Gas Pollution Pricing Act (Bill C-234). Passed Commons. Passed Senate December 12, 2023. *Summary: This enactment amends the Greenhouse Gas Pollution Pricing Act to expand the definition of eligible farming machinery and extend the exemption for qualifying farming fuel to marketable natural gas and propane.*
- An Act to amend the Health of Animals Act (biosecurity on farms) (C-275). Passed Commons. Senate reported with amendment October 29, 2024. *Summary: This enactment amends the Health of Animals Act to make it an offence to enter, without lawful authority or excuse, a place in which animals are kept if doing so could result in the exposure of the animals to a disease or toxic substance that is capable of affecting or contaminating them.*
- An Act to amend the Income Tax Act (deduction of travel expenses for tradespersons) (Bill C-241). Passed Commons. Senate reported without amendment December 6, 2023. *Summary: This enactment amends the Income Tax Act to allow tradespersons and indentured apprentices to deduct from their income amounts expended for travelling where they were employed in a construction activity at a job site that is located at least 120 km away from their ordinary place of residence.*
- An Act to amend the Indian Act (new registration entitlements) (Bill C-38). Commons 1<sup>st</sup> Reading December 14, 2022. *Summary: This enactment amends the Indian Act to provide, among other things, new entitlements to registration in the Indian Register in response to the challenge of certain provisions of the Act under the Canadian Charter of Rights and Freedoms in *Nicholas v. Canada (Attorney General)* and that the persons who have become so entitled also have the right to have their names entered in a Band List maintained in the Department of Indigenous Services.*
- An Act to amend the Interpretation Act and to make related amendments to other Acts (Bill S-13). Royal Assent November 27, 2024: S.C. 2024, c. 30. In force as set out in the Act. *Summary: This enactment amends the Interpretation Act to provide that Acts of Parliament and regulations are to be construed as upholding the Aboriginal and treaty rights of Indigenous peoples recognized and affirmed by section 35 of the Constitution Act, 1982, and not as abrogating or derogating from them. It also amends or repeals similar provisions in other Acts known as non-derogation clauses.*
- An Act to amend the Judges Act (Bill C-9). Royal Assent June 22, 2023: S.C. 2023, c. 18. In force as set out in the Act. *Summary: This enactment amends the Judges Act to replace the process through which the conduct of federally appointed judges is reviewed by the Canadian Judicial Council. It establishes a new process for reviewing allegations of misconduct that are not serious enough to warrant a judge's removal from office and makes changes to the*



*process by which recommendations regarding removal from office can be made to the Minister of Justice. As with the provisions it replaces, this new process also applies to persons, other than judges, who are appointed under an Act of Parliament to hold office during good behaviour.*

An Act to amend the Judges Act (Bill S-3). Senate 1<sup>st</sup> Reading December 1, 2021. *Summary: This enactment amends the Judges Act to replace the process through which the conduct of federally appointed judges is reviewed by the Canadian Judicial Council. It establishes a new process for reviewing allegations of misconduct that are not serious enough to warrant a judge's removal from office and makes changes to the process by which recommendations regarding removal from office can be made to the Minister of Justice. As with the provisions it replaces, this new process also applies to persons, other than judges, who are appointed under an Act of Parliament to hold office during good behaviour.*

An Act to amend the Immigration and Refugee Protection Act, to make consequential amendments to other Acts and to amend the Immigration and Refugee Protection Regulations (Bill S-8). Royal Assent June 22, 2023: S.C. 2023, c. 19. In force as set out in the Act. *Summary: This enactment amends the Immigration and Refugee Protection Act to, among other things, (a) reorganize existing inadmissibility provisions relating to sanctions to establish a distinct ground of inadmissibility based on sanctions; (b) expand the scope of inadmissibility based on sanctions to include not only sanctions imposed on a country but also those imposed on an entity or a person; and (c) expand the scope of inadmissibility based on sanctions to include all orders and regulations made under section 4 of the Special Economic Measures Act. It also makes consequential amendments to the Citizenship Act and the Emergencies Act. Finally, it amends the Immigration and Refugee Protection Regulations to, among other things, provide that the Minister of Public Safety and Emergency Preparedness, instead of the Immigration Division, will have the authority to issue a removal order on grounds of inadmissibility based on sanctions under new paragraph 35.1(1)(a) of the Immigration and Refugee Protection Act.*

An Act to amend the Old Age Security Act (Guaranteed Income Supplement) (Bill C-12). Royal Assent March 3, 2022: S.C. 2022, c. 1. In force as set out in the Act. *Summary: This enactment amends the Old Age Security Act to exclude from a person's income any payment under the Canada Emergency Response Benefit Act, Part VIII.4 of the Employment Insurance Act, the Canada Recovery Benefits Act or the Canada Worker Lockdown Benefit Act for the purposes of calculating the amount of the guaranteed income supplement and allowances payable in respect of any month after June 2022.*

An Act to amend the Parliament of Canada Act and to make consequential and related amendments to other Acts (Bill S-2). Passed Senate December 7, 2021. *Summary: This enactment amends the Parliament of Canada Act and makes consequential and related amendments to other Acts to, among other things: (a) change the additional annual allowances that are paid to senators who occupy certain positions so that the government's representatives and*

*the Opposition in the Senate are eligible for the allowances for five positions each and the three other recognized parties or parliamentary groups in the Senate with the greatest number of members are eligible for the allowances for four positions each; (b) provide that the Leader of the Government in the Senate or Government Representative in the Senate, the Leader of the Opposition in the Senate and the Leader or Facilitator of every other recognized party or parliamentary group in the Senate are to be consulted on the appointment of certain officers and agents of Parliament; and (c) provide that the Leader of the Government in the Senate or Government Representative in the Senate, the Leader of the Opposition in the Senate and the Leader or Facilitator of every other recognized party or parliamentary group in the Senate may change the membership of the Standing Senate Committee on Internal Economy, Budgets and Administration.*

- An Act to amend the Parliament of Canada Act (Parliamentary Visual Artist Laureate) (Bill S-202). Royal Assent June 20, 2024: S.C. 2024, c. 9. In force as set out in the Act. *Summary: This enactment creates the position of Parliamentary Visual Artist Laureate. It also corrects a reference to the Canada Council for the Arts in the English version of the Parliament of Canada Act.*
- An Act to amend the Radiocommunication Act (Bill S-242). Passed Senate. Commons 1<sup>st</sup> Reading May 11, 2023. *Summary: This enactment amends the Radiocommunication Act to require spectrum licence holders to deploy the spectrum to at least 50% of the population within the geographic area covered by the spectrum licence.*
- An Act to amend the Telecommunications Act (transparent and accurate broadband services information) (Bill C-288). Royal Assent June 20, 2024: S.C. 2024, c. 10. In force as set out in the Act. *Summary: This enactment amends the Telecommunications Act to require Canadian carriers to make easily available certain information in respect of the fixed broadband services that they offer. It also requires the Canadian Radio-television and Telecommunications Commission to hold public hearings to inform its determinations on how Canadian carriers are to fulfill this obligation.*
- An Act to change the name of the electoral district of Châteauguay-Lacolle (Bill S-207). Passed Senate. Commons 1<sup>st</sup> Reading February 10, 2022. *Summary: This enactment changes the name of the electoral district of Châteauguay-Lacolle to 'Châteauguay-Les Jardins-de-Napierville'.*
- An Act to provide further support in response to COVID-19 (Bill C-2). Passed Commons. Passed Senate December 16, 2021. *Summary: Part 1 amends the Income Tax Act and the Income Tax Regulations to extend subsidies under the Canada Emergency Wage Subsidy (CEWS), the Canada Emergency Rent Subsidy (CERS), and the Canada Recovery Hiring Program until May 7, 2022, as part of the response to the COVID-19 pandemic. Support under the CEWS and the CERS would be available to the tourism and hospitality sector and to the hardest-hit organizations that face significant revenue declines. Eligible entities under these rules would need to demonstrate a revenue decline over the course of 12 months of the pandemic, as well as a current-month revenue decline. In addition, organizations subject to a qualifying*

public health restriction would be eligible for support, if they have one or more locations subject to a public health restriction lasting for at least seven days that requires them to cease some or all of their activities. Part 1 also allows the government to extend the subsidies by regulation but no later than July 2, 2022. Part 2 enacts the Canada Worker Lockdown Benefit Act to authorize the payment of the Canada worker lockdown benefit in regions where a lockdown is imposed for reasons related to COVID-19. It also makes consequential amendments to the Income Tax Act and the Income Tax Regulations. Part 3 amends the Canada Recovery Benefits Act. It also makes a related amendment to the Canada Recovery Benefits Regulations. Part 4 amends the Canada Labour Code to, among other things, create a regime that provides for a leave of absence related to COVID-19. It also makes a related amendment to the Budget Implementation Act, 2021, No. 1.

An Act to repeal section 43 of the Criminal Code (Truth and Reconciliation Commission of Canada's call to action number 6) (Bill S-251). Senate 2<sup>nd</sup> Reading June 13, 2023. *Summary: This enactment repeals section 43 of the Criminal Code (correction of child by force) in order to respond to the Truth and Reconciliation Commission of Canada's call to action number 6.*

Anishinabek Nation Governance Agreement Act (Bill S-10). Royal Assent June 23, 2022: S.C. 2022, c. 9. In force as set out in the Act – (SI/2022-48) October 1, 2022 is fixed as the day on which Part 1 of the Act comes into force, other than section 6, which came into force on assent. *Summary: Part 1 enacts the Anishinabek Nation Governance Agreement Act and makes related and consequential amendments to other Acts. Part 2 amends the Sechelt Indian Band Self-Government Act. It also amends transitional provisions and makes consequential amendments to other Acts. Part 3 amends the Yukon First Nations Self-Government Act to ensure that entering into funding agreements no longer requires the approval of the Governor in Council.*

Appropriation Act No. 1, 2022-23 (Bill C-16). Royal Assent March 31, 2022: S.C. 2022, c. 4. In force as set out in the Act. *Summary: This enactment grants the sum of \$75,483,404,546 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2023 that are not otherwise provided for.*

Appropriation Act No. 1, 2023-24 (Bill C-44). Royal Assent March 30, 2023: S.C. 2023, c. 4. In force as set out in the Act. *Summary: This enactment grants the sum of \$89,678,492,027 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2024 that are not otherwise provided for.*

Appropriation Act No. 1, 2024-25 (Bill C-68). Royal Assent March 22, 2024: S.C. 2024, c. 6. *Summary: This enactment grants the sum of \$74,011,525,281 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2025 that are not otherwise provided for.*

Appropriation Act No. 2, 2022-23 (Bill C-24). Royal Assent June 23, 2022: S.C. 2022, c. 7. In force as set out in the Act. *Summary: his enactment grants the sum of \$115,056,882,851 towards defraying charges and expenses of the fed-*

*eral public administration for the fiscal year ending March 31, 2023 that are not otherwise provided for.*

Appropriation Act No. 2, 2023-24 (Bill C-54). Royal Assent June 22, 2023, c. 24. In force as set out in the Act. *Summary: This enactment grants the sum of \$108,700,157,669 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2024 that are not otherwise provided for.*

Appropriation Act No. 2, 2024-25 (Bill C-74). Royal Assent June 20, 2024: S.C. 2024, c. 18. In force as set out in the Act. *Summary: This enactment grants the sum of \$117,781,852,267 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2025 that are not otherwise provided for.*

Appropriation Act No. 3, 2022-23 (Bill C-25). Royal Assent June 23, 2022: S.C. 2022, c. 8. In force as set out in the Act. *Summary: This enactment grants the sum of \$8,795,403,218 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2023 that are not otherwise provided for.*

Appropriation Act No. 3, 2023-24 (Bill C-55). Royal Assent June 22, 2023, c. 25. In force as set out in the Act. *Summary: This enactment grants the sum of \$20,478,605,110 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2024 that are not otherwise provided for.*

Appropriation Act No. 3, 2024-25 (Bill C-75). Royal Assent June 20, 2024: S.C. 2024, c. 19. In force as set out in the Act. *Summary: This enactment grants the sum of \$11,187,495,220 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2025 that are not otherwise provided for.*

Appropriation Act No. 4, 2021-22 (Bill C-6). Passed Commons. Passed Senate December 15, 2021. *Summary: This enactment grants the sum of \$8,749,898,306 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2022 that are not otherwise provided for.*

Appropriation Act No. 4, 2022-23 (Bill C-36). Royal Assent December 15, 2022: S.C. 2022, c. 20. In force as set out the Act. *Summary: This enactment grants the sum of \$20,796,964,176 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2023 that are not otherwise provided for.*

Appropriation Act No. 5, 2021-22 (Bill C-15). Royal Assent March 31, 2022: S.C. 2002, c. 3. In force as set out in the Act. *Summary: This enactment grants the sum of \$13,209,519,773 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2022 that are not otherwise provided for.*

Appropriation Act No. 5, 2022-23 (Bill C-43). Royal Assent March 30, 2023: S.C. 2023, c. 3. In force as set out in the Act. *Summary: This enactment grants the sum of \$4,680,112,624 towards defraying charges and expenses of*

- the federal public administration for the fiscal year ending March 31, 2023 that are not otherwise provided for.*
- Appropriation Act No. 5, 2023-24 (Bill C-67). Royal Assent March 22, 2024: S.C. 2024, c. 5. In force as set out in the Act. *Summary: This enactment grants the sum of \$8,911,403,788 towards defraying charges and expenses of the federal public administration for the fiscal year ending March 31, 2024 that are not otherwise provided for.*
- Arab Heritage Month Act (Bill C-232). Passed Commons. Senate reported without amendment October 24, 2024. *Summary: This enactment designates the month of April as 'Arab Heritage Month'.*
- Balancing the Bank of Canada's Independence and Accountability Act (Bill S-275). Senate 1<sup>st</sup> Reading September 20, 2023. *Summary: This enactment amends the Bank of Canada Act to clarify the Bank's mandate, define the objectives of monetary policy, and establish a monetary policy committee while specifying that committee's duties in order to better balance the Bank's independence with its accountability to Canadians. It also sets out assessment and transparency requirements and provides for an agreement between the Bank and the Government of Canada respecting monetary policy.*
- Budget Implementation Act, 2022, No. 1 (Bill C-19). Royal Assent June 23, 2022: S.C. 2022, c. 10. In force as set out in the Act – (SI/2022-46) September 23, 2022 is fixed as the day on which ss. 333(3), (4) and 371 to 373 of the Act come into force – (SI/2022-51) October 26, 2022 is fixed as the day on which Division 18 of Part 5 of the Act comes into force – (SI/2022-58) December 30, 2022 is fixed as the day on which Division 16 of Part 5 of the Act comes into force – (SI/2023-14) the day after the day on which this Order is made is fixed as the day on which Division 28 of Part 5 of the Act comes into force – (SI/2023-62) January 22, 2024 is fixed as the day on which ss. 431 to 433 of the Act come into force – (SI/2024-8) the day on which this Order is made is fixed as the day on which sections 302, 304 to 306, and 308 to 328 of the Act come into force. *Summary: This bill amends various other Acts.*
- Budget Implementation Act, 2023, No. 1 (Bill C-47). Royal Assent June 22, 2023: S.C. 2023, c. 26. In force as set out in the Act – (SI/2024-25) January 1, 2025 is fixed as the day on which ss. 610 to 612 of the Act come into Force. *Summary: This bill amends various other Acts.*
- Budget Implementation Act, 2024, No. 1 (Bill C-69). Royal Assent June 20, 2024: S.C. 2024, c. 17. Subsection 413(4) and sections 414 and 415 come into force on a day to be fixed by order of the Governor in Council. *Summary: This bill amends various other Acts.*
- Building a Green Prairie Economy Act Building a Green Prairie Economy Act (Bill C-235). Royal Assent December 15, 2022: S.C. 2022, c. 21. In force as set out in the Act. *Summary: This enactment requires the Minister of Industry, in collaboration with the Minister of the Environment, the Minister of Transport, the Minister of Finance, the Minister of Natural Resources and any minister responsible for economic development in the Prairie provinces, to develop a framework for local cooperation and engagement in the imple-*

*mentation of federal programs across various sectors to build a green economy in the Prairie provinces.*

- Canada Disability Benefit Act (Bill C-22). Royal Assent June 22, 2023: S.C. 2023, c. 17. Act comes into force on a day to be fixed by order of the Governor in Council, but no later than the first anniversary of the day on which it receives royal assent. *Summary: This enactment establishes the Canada disability benefit to reduce poverty and to support the financial security of working-age persons with disabilities. It sets out general provisions for the administration of the benefit and authorizes the Governor in Council to implement most of the benefit's design elements through regulations. It also makes a consequential amendment to the Income Tax Act.*
- Canada Early Learning and Child Care Act (Bill C-35). Royal Assent March 19, 2024: S.C. 2024, c. 2. Sections 9 to 15 come into force on a day to be fixed by order of the Governor in Council. *Summary: This enactment sets out the Government of Canada's vision for a Canada-wide early learning and child care system. It also sets out the Government of Canada's commitment to maintaining long-term funding relating to early learning and child care to be provided to the provinces and Indigenous peoples. Finally, it creates the National Advisory Council on Early Learning and Child Care.*
- Canada Water Agency Act (enactment)...See...Fall Economic Statement Implementation Act, 2023 (Bill C-59) S.C. 2024, c. 15.
- Canada-Ukraine Free Trade Agreement Implementation Act, 2023 (Bill C-57). Royal Assent March 19, 2024: S.C. 2024, c. 3. The Act comes into force on a day to be fixed by order of the Governor in Council. Sections 19(3), 20(2) and (4), 21(2), 22(2), 23(2), 24(2), 25(2) and 26(2) of the Act come into force on the sixth anniversary of the day fixed under subsection (1); (SI/2024-16) – fixes the date of entry into force of the Free Trade Agreement between Canada and Ukraine, done at Ottawa on September 22, 2023, as the day on which that Act comes into force, other than sections 19(3), 20(2) and (4), 21(2), 22(2), 23(2), 24(2), 25(2) and 26(2). *Summary: This enactment implements the Canada-Ukraine Free Trade Agreement, done at Ottawa on September 22, 2023. Among other things, the enactment (a) sets out rules of interpretation; (b) specifies that no recourse is to be taken on the basis of ss. 9 to 15 or any order made under those sections, or on the basis of the provisions of that Agreement, without the consent of the Attorney General of Canada; (c) approves that Agreement; (d) provides for the payment by Canada of its share of the expenditures associated with the operation of the institutional and administrative aspects of that Agreement; (e) gives the Governor in Council the power to make orders in accordance with that Agreement; and (f) amends certain Acts to give effect to Canada's obligations under that Agreement. Finally, the enactment repeals the Canada-Ukraine Free Trade Agreement Implementation Act that was enacted in 2017.*
- Canadian Postal Safety Act (Bill S-256). Senate reported with amendments October 8, 2024. *Summary: This enactment amends the Canada Post Corporation Act to designate certain statutes under which items in the course of post may*

- be seized, detained or retained. It makes related amendments to the Criminal Code, the Controlled Drugs and Substances Act and the Cannabis Act.*
- Canadian Sustainable Jobs Act (Bill C-50). Royal Assent June 13, 2024: S.C. 2024, c. 13. In force as set out in the Act. *Summary: This enactment establishes an accountability, transparency and engagement framework to facilitate and promote economic growth, the creation of sustainable jobs and support for workers and communities in Canada in the shift to a net-zero economy. Accordingly, the enactment: (a) provides that the Governor in Council may designate a Minister for the purposes of the Act as well as specified Ministers; (b) establishes a Sustainable Jobs Partnership Council to provide the Minister and the specified Ministers, through a process of social dialogue, with independent advice with respect to measures to foster the creation of sustainable jobs, measures to support workers, communities and regions in the shift to a net-zero economy and matters referred to it by the Minister; (c) requires the tabling of a Sustainable Jobs Action Plan in each House of Parliament every five years; (d) provides for the establishment of a Sustainable Jobs Secretariat to support the implementation of the Act; and (e) provides for a review of the Act within 10 years of its coming into force and by the end of each subsequent period of 10 years.*
- Chignecto Isthmus Dykeland System Act (Bill S-273). Passed Senate June 11, 2024. *Summary: This enactment declares the Chignecto Isthmus Dykeland System and related works to be works for the general advantage of Canada.*
- Child Health Protection Act (Bill C-252). Passed Commons. Senate reported without amendment November 28, 2024. *Summary: This enactment amends the Food and Drugs Act to prohibit food and beverage marketing directed at persons under 13 years of age.*
- Cluster Munitions Investment Prohibition Act (Bill S-225). Senate 2<sup>nd</sup> Reading October 26, 2022. *Summary: This enactment creates a new prohibition against investing in an entity that has breached a prohibition relating to cluster munitions, explosive submunitions and explosive bomblets.*
- Commissioner for Modern Treaty Implementation Act (Bill C-77). Commons 1<sup>st</sup> Reading October 10, 2024. *Summary: This enactment provides for the appointment of a Commissioner for Modern Treaty Implementation to conduct reviews and performance audits of the activities of government institutions related to the implementation of modern treaties. It also establishes the Office of the Commissioner for Modern Treaty Implementation for the purpose of assisting the Commissioner in the fulfillment of their mandate and the exercise of their powers and the performance of their duties and functions. Finally, it makes consequential amendments to other Acts.*
- Connected Care For Canadians Act (Bill C-72). Commons 1<sup>st</sup> Reading June 6, 2024. *Summary: This enactment aims, among other things, to ensure that health information technology that is licensed, sold or supplied as a service by a vendor is interoperable and to prohibit data blocking by the vendor in order to promote a connected, secure and person-centered health system.*
- Cost of Living Relief Act, No. 1 (Targeted Tax Relief) (Bill C-30). Royal Assent October 18, 2022: S.C. 2022, c. 13. In force as set out in the Act. *Summary:*

*This enactment amends the Income Tax Act in order to double the Goods and Services Tax/Harmonized Sales Tax (GST/HST) credit for six months, effectively increasing the maximum annual GST/HST credit amounts by 50% for the 2022-2023 benefit year.*

- Cost of Living Relief Act, No. 2 (Targeted Support for Households) (Bill C-31). Royal Assent November 17, 2022; S.C. 2022, c. 14. In force as set out in the Act. *Summary: Part 1 enacts the Dental Benefit Act, which provides for the establishment of an application-based interim dental benefit. The benefit provides interim direct financial support for parents for dental care services received by their children under 12 years of age in the period starting in October 2022 and ending in June 2024. Part 2 enacts the Rental Housing Benefit Act, which provides for the establishment of a one-time rental housing benefit for eligible persons who have paid rent in 2022 for their principal residence and who apply for the benefit. Finally, Part 3 makes related amendments to the Income Tax Act, the Excise Tax Act and the Excise Act, 2001.*
- Countering Foreign Interference Act (Bill C-70). Royal Assent June 20, 2024; S.C. 2024, c. 16. In force as set out of the Act. *Summary: This Act amends various other Acts.*
- Declaration on the Essential Role of Artists and Creative Expression in Canada Act (Bill S-208). Passed Senate. Commons 1<sup>st</sup> Reading October 19, 2022. *Summary: This enactment provides a framework for the Government of Canada's implementation of the Declaration on the Essential Role of Artists and Creative Expression in Canada, including by requiring the Minister of Canadian Heritage to prepare and implement an action plan to give expression to the Declaration.*
- Dental Benefit Act (enactment)...See...Cost of Living Relief Act, No. 2 (Targeted Support for Households) (Bill C-31) S.C. 2022, c. 14.
- Department of Housing, Infrastructure and Communities Act (enactment)...See...Fall Economic Statement Implementation Act, 2023 (Bill C-59) S.C. 2024, c. 15.
- Digital Charter Implementation Act, 2022 (Bill C-27). Commons 2<sup>nd</sup> Reading April 24, 2023. *Summary: Part 1 enacts the Consumer Privacy Protection Act to govern the protection of personal information of individuals while taking into account the need of organizations to collect, use or disclose personal information in the course of commercial activities. In consequence, it repeals Part 1 of the Personal Information Protection and Electronic Documents Act and changes the short title of that Act to the Electronic Documents Act. It also makes consequential and related amendments to other Acts. Part 2 enacts the Personal Information and Data Protection Tribunal Act, which establishes an administrative tribunal to hear appeals of certain decisions made by the Privacy Commissioner under the Consumer Privacy Protection Act and to impose penalties for the contravention of certain provisions of that Act. It also makes a related amendment to the Administrative Tribunals Support Service of Canada Act. Part 3 enacts the Artificial Intelligence and Data Act to regulate international and interprovincial trade and commerce in artificial intelligence systems by requiring that certain persons adopt measures*



*to mitigate risks of harm and biased output related to high-impact artificial intelligence systems. That Act provides for public reporting and authorizes the Minister to order the production of records related to artificial intelligence systems. That Act also establishes prohibitions related to the possession or use of illegally obtained personal information for the purpose of designing, developing, using or making available for use an artificial intelligence system and to the making available for use of an artificial intelligence system if its use causes serious harm to individuals.*

Digital Services Tax Act (enactment)...See...Fall Economic Statement Implementation Act, 2023 (Bill C-59) S.C. 2024, c. 15.

Economic and Fiscal Update Implementation Act, 2021 (Bill C-8). Royal Assent June 9, 2022: S.C. 2022, c. 5. In force as set out in the Act. *Summary: This bill amends various Acts.*

Effective and Accountable Charities Act (Bill S-216). Passed Senate December 9, 2021. Commons 1<sup>st</sup> Reading February 3, 2022. *Summary: This enactment amends the Income Tax Act to permit charities to provide their resources to a person who is not a qualified donee, provided that they take reasonable steps to ensure those resources are used exclusively for a charitable purpose.*

Electoral Participation Act (Bill C-65). Commons 2<sup>nd</sup> Reading June 19, 2024. *Summary: This enactment amends the Canada Elections Act to, among other things, (a) provide for two additional days of advance polling; (b) authorize returning officers to constitute polling divisions that consist of a single institution, or part of an institution, where seniors or persons with a disability reside and provide for the procedures for voting at polling stations in those polling divisions; (c) update the process for voting by special ballot; (d) provide for the establishment of offices for voting by special ballot at post-secondary educational institutions; (e) provide for new requirements relating to political parties' policies for the protection of personal information; (f) establish new prohibitions and modify existing prohibitions, including in relation to foreign influence in the electoral process, the provision of false or misleading information respecting elections and the acceptance or use of certain contributions; and (g) expand the scope of certain provisions relating to the administration and enforcement of that Act, including by granting the Commissioner of Canada Elections certain powers in respect of any conspiracy or attempt to commit, or being an accessory after the fact or counselling in relation to, a contravention of that Act. The enactment also provides that the Chief Electoral Officer must make a report on the measures that need to be taken to implement a three-day polling period, a report on the measures that need to be taken to enable electors to vote at any place in their polling station, a report on the feasibility of enabling electors to vote at any polling station in their electoral district and a report proposing a process for the determination of whether a political party has as one of its fundamental purposes the promotion of hatred against an identifiable group of persons.*

Enacting Climate Commitments Act (Bill S-243). Senate 2<sup>nd</sup> Reading June 8, 2023. *Summary: Part 1 enacts the Climate-Aligned Finance Act which, among other things, establishes climate commitments and obligations of vari-*

*ous entities in relation to them. Subsequent parts establish further obligations on entities – primarily financial entities – in relation to the climate commitments provided for under the Climate-Aligned Finance Act.*

Enhancing Transparency and Accountability in the Transportation System Act (Bill C-52). Commons 1<sup>st</sup> Reading June 20, 2023. *Summary: This enactment enacts the Air Transportation Accountability Act, amends the Canada Transportation Act and the Canada Marine Act.*

Fairness for All Canadian Taxpayers Act (measuring the tax gap to fight international tax evasion) (Bill S-258). Passed Senate. Commons 1<sup>st</sup> Reading June 19, 2024. *Summary: This enactment amends the Canada Revenue Agency Act to require the Canada Revenue Agency to list all convictions for tax evasion – including international tax evasion – in the annual report it submits to the Minister of National Revenue. It also requires the Agency, once every three years, to include statistics on the tax gap in the annual report. In addition, this enactment specifies that the Minister is to provide data on the tax gap to the Parliamentary Budget Officer.*

Fall Economic Statement Implementation Act, 2022 (Bill C-32). Royal Assent December 15, 2022: S.C. 2022, c. 19. In force as set out in the Act. The day after the day on which this Order is made is fixed as the day on which sections 146, 147, 150 to 152, 157,158, 159(2) and (3), 160 and 166 of the Act come into force. *Summary: This act amends various other acts.*

Fall Economic Statement Implementation Act, 2023 (Bill C-59). Royal Assent June 20, 2024: S.C. 2024, c. 15. In force as set out in the Act – (SI/2024-33) the day on which this Order is made is fixed as the day on which section 96(1) of the Act comes into force. *Summary: This act amends various other acts.*

Federal Law-Civil Law Harmonization Act, No. 4 (Bill S-11). Passed Senate. Commons 1<sup>st</sup> Reading February 7, 2023. *Summary: This enactment is the fourth in a series of enactments drafted in the course of the harmonization of federal statutes by the Department of Justice of Canada as a result of the coming into force of the Civil Code of Québec in 1994, which substantially changed the concepts, institutions and terminology of civil law. It amends 52 statutes, including the Acts governing financial institutions – the Bank Act, the Cooperative Credit Associations Act, the Insurance Companies Act and the Trust and Loan Companies Act – and other Acts including the Access to Information Act, the Financial Administration Act, the Interpretation Act and the Official Languages Act, in order to ensure that each language version takes into account the common law and the civil law.*

Federal Framework on Autism Spectrum Disorder Act (Bill S-203). Royal Assent March 30, 2023: S.C. 2023, c. 2. In force as set out in the Act. *Summary: This enactment provides for the development of a federal framework designed to support autistic Canadians, their families and their caregivers.*

Fighting Against Forced Labour and Child Labour in Supply Chains Act (Bill S-211). Royal Assent May 11, 2023: S.C. 2023, c. 9. This Act comes into force on January 1 of the year following the year in which it receives royal assent. *Summary: This enactment enacts the Fighting Against Forced Labour and*

*Child Labour in Supply Chains Act, which imposes an obligation on certain government institutions and private-sector entities to report on the measures taken to prevent and reduce the risk that forced labour or child labour is used by them or in their supply chains. The Act provides for an inspection regime applicable to entities and gives the Minister the power to require an entity to provide certain information. This enactment also amends the Customs Tariff to allow for a prohibition on the importation of goods manufactured or produced, in whole or in part, by forced labour or child labour as those terms are defined in the Fighting Against Forced Labour and Child Labour in Supply Chains Act.*

Financial Protection for Fresh Fruit and Vegetable Farmers Act (Bill C-280). Passed Commons. Senate reported with amendments November 5, 2024. *Summary: This enactment amends the Bankruptcy and Insolvency Act and the Companies' Creditors Arrangement Act to provide that the perishable fruits and vegetables sold by a supplier to a purchaser, as well as the proceeds of sale of those fruits and vegetables, are to be held in trust by the purchaser for the supplier in the event that the purchaser has not fully paid for the fruits or vegetables and becomes bankrupt or the subject to a receivership or applies to the court to sanction a compromise or an arrangement.*

**First Nations Clean Water Act (Bill C-61). Commons reported with amendments December 2, 2024. Summary: This enactment affirms that the inherent right to self-government, recognized and affirmed by section 35 of the Constitution Act, 1982, includes the jurisdiction of First Nations in relation to water, source water, drinking water, wastewater and related infrastructure on, in and under First Nation lands. It sets out principles, such as substantive equality, to guide the provision for First Nations of clean and safe drinking water and the effective treatment and disposal of wastewater on First Nation lands. It provides for minimum standards for water quality and quantity and wastewater effluent. It also provides pathways to facilitate source water protection.**

Food Day in Canada Act (Bill S-227). Royal Assent May 11, 2023: S.C. 2023, c. 10. In force as set out in the Act. *Summary: This enactment designates the Saturday before the first Monday in August in each and every year as 'Food Day in Canada'.*

Foreign Influence Transparency and Accountability Act (enactment)....See....Countering Foreign Interference Act (Bill C-70) S.C. 2024, c. 16.

Frozen Assets Repurposing Act (Bill S-217). Senate reported with amendments April 7, 2022. *Summary: This enactment provides for the reporting and disposition of assets seized, frozen or sequestered under the Special Economic Measures Act, the Freezing Assets of Corrupt Foreign Officials Act and the Justice for Victims of Corrupt Foreign Officials Act (Sergei Magnitsky Law).*

Global Minimum Tax Act (enactment)....See....Budget Implementation Act, 2024, No. 1 (Bill C-69) S.C. 2024, c. 17.

Haida Nation Recognition Act (Bill S-16). Royal Assent November 7, 2024: S.C. 2025, c. 29. In force as set out in the Act. *Summary: This enactment imple-*

ments certain sections of the agreement entitled ‘Nang K’uula •Nang K’uulaas Recognition Agreement’.

Hellenic Heritage Month Act (Bill S-259). Senate 2<sup>nd</sup> Reading May 30, 2024.

*Summary: This enactment designates the month of March as ‘Hellenic Heritage Month’.*

Historic Places of Canada Act (Bill C-23). Commons 1<sup>st</sup> Reading June 7, 2022.

*Summary: This enactment enacts the Historic Places of Canada Act, which provides for the designation of places, persons and events that are of national historic significance or national interest and fosters the protection and conservation of the heritage value of the designated places. The Act also contains transitional provisions, makes related and consequential amendments to other Acts and repeals the Historic Sites and Monuments Act.*

Increasing the Identification of Criminals Through the Use of DNA Act (Bill S-231). Senate reported with amendments December 12, 2023.

*Summary: This enactment amends the Criminal Code, the Criminal Records Act, the National Defence Act and the DNA Identification Act to promote the DNA collection system and increase the number of DNA profiles stored in the national DNA data bank.*

International Human Rights Act (Bill C-281). Passed Commons. Senate 2<sup>nd</sup> Reading May 29, 2024.

*Summary: This enactment amends the Department of Foreign Affairs, Trade and Development Act to impose certain reporting requirements on the Minister of Foreign Affairs in relation to international human rights. It also amends the Justice for Victims of Corrupt Foreign Officials Act (Sergei Magnitsky Law) to require the Minister of Foreign Affairs to respond within 40 days to a report submitted by a parliamentary committee that recommends that sanctions be imposed under that Act against a foreign national. In addition, this enactment amends the Broadcasting Act to prohibit the issue, amendment or renewal of a licence in relation to a broadcasting undertaking that is vulnerable to being influenced by a foreign national or entity that has committed acts or omissions that the Senate or the House of Commons has recognized as genocide or that is subject to sanctions under the Justice for Victims of Corrupt Foreign Officials Act (Sergei Magnitsky Law) or under the Special Economic Measures Act. Finally, it amends the Prohibiting Cluster Munitions Act to prohibit a person from investing in an entity that has contravened certain provisions of the Act.*

International Mother Language Day Act (Bill S-214). Royal Assent, April 27,

2023: S.C. 2023, c. 5. In force as set out in the Act. *Summary: This enactment designates the 21st day of February in each and every year as ‘International Mother Language Day’.*

International Tax Justice and Cooperation Day Act (Bill S-264). Senate 2<sup>nd</sup> Reading May 9, 2024.

*Summary: This enactment designates June 4 as ‘International Tax Justice and Cooperation Day’.*

Jane Goodall Act (Bill S-241). Senate 2<sup>nd</sup> Reading June 8, 2023.

*Summary: This enactment amends the Criminal Code to create offences respecting great apes, elephants and certain other non-domesticated animals in captivity, including respecting captive breeding. It also amends the Wild Animal and*

*Plant Protection and Regulation of International and Interprovincial Trade Act to require a permit for the import, export or interprovincial transportation and captive breeding of great apes, elephants and certain other non-domesticated animals.*

Jury Duty Appreciation Week Act (Bill S-252). Passed Senate June 4, 2024. *Summary: This enactment designates the second week of May in each and every year as 'Jury Duty Appreciation Week'.*

Lebanese Heritage Month Act (Bill S-246). Royal Assent June 20, 2023: S.C. 2023, c. 13. In force as set out in the Act. *Summary: This enactment designates the month of November as "Lebanese Heritage Month".*

Military Justice System Modernization Act (Bill C-66). Commons 1<sup>st</sup> Reading March 24, 2024. *Summary: This enactment amends provisions of the National Defence Act that relate to the military justice system in response to the Report of the Third Independent Review Authority to the Minister of National Defence and the Report of the Independent External Comprehensive Review of the Department of National Defence and the Canadian Armed Forces. The enactment amends the National Defence Act to remove military judges from the summary hearing system and to provide that, in the context of a service offence, an individual acting on behalf of a victim may request that a victim's liaison officer be appointed to assist them. It further amends that Act to harmonize the sex offender information and publication ban provisions with the amendments made to the Criminal Code in An Act to amend the Criminal Code, the Sex Offender Information Registration Act and the International Transfer of Offenders Act. Finally, it amends the Criminal Code to, among other things, provide superior courts of criminal jurisdiction with the jurisdiction to hear applications for an exemption in respect of orders to comply with the Sex Offender Information Registration Act made under the National Defence Act and applications to vary the duration of such orders.*

Miscarriage of Justice Review Commission Act (David and Joyce Milgaard's Law) (Bill C-40). Passed Commons. Senate reported without amendment November 26, 2024. *Summary: This enactment amends the Criminal Code to, among other things, (a) establish an independent body to be called the Miscarriage of Justice Review Commission; (b) replace the review process set out in Part XXI.1 with a process in which applications for reviews of findings and verdicts on the grounds of miscarriage of justice are made to the Commission instead of to the Minister of Justice; (c) confer on the Commission powers of investigation to carry out its functions; (d) provide that the Commission may direct a new trial or hearing or refer a matter to the court of appeal if it has reasonable grounds to conclude that a miscarriage of justice may have occurred and considers that it is in the interests of justice to do so; (e) authorize the Commission to provide supports to applicants in need and to provide the public, including potential applicants, with information about its mandate and miscarriages of justice; and (f) require the Commission to make and publish policies and to present and publish annual reports that include demographic and performance measurement data. The enactment also makes consequential amendments to other Acts and repeals the Regula-*

*tions Respecting Applications for Ministerial Review – Miscarriages of Justice.*

Miscellaneous Statute Law Amendment Act, 2023 (Bill S-17). Passed Senate June 19, 2024. *Summary: This enactment is the 13th in a series of bills introduced under the Miscellaneous Statute Law Amendment (MSLA) Program. It amends 58 Acts and three related regulations to correct errors in grammar, spelling, terminology and punctuation, erroneous cross-references, archaic wording and discrepancies between the English version and the French versions. It also updates the designation of professionals and the name of a tribunal. For example, it changes the name the Review Tribunal to the Canada Agricultural Review Tribunal to reflect the operational name of that tribunal. Other amendments correct the names of courts in certain provinces to reflect changes resulting from the reorganization of the courts in question. Finally, it repeals three provisions from Acts that no longer have any application, for example, the repeal of section 12 of the Department of Transport Act. This enactment has been drafted based on the Twenty-First Report of the Standing Committee on Justice and Human Rights tabled in the House of Commons on February 12, 2024 and the Twenty-First Report of the Standing Senate Committee on Legal and Constitutional Affairs tabled in the Senate on December 12, 2023.*

National Council for Reconciliation Act (Bill C-29). Royal Assent April 30, 2024; S.C. 2024, c. 8. This Act comes into force on a day to be fixed by order of the Governor in Council – (SI/2024-31) July 2, 2024 is fixed as the day on which this Act comes into force. *Summary: This enactment provides for the establishment of a national council for reconciliation as an independent, non-political, permanent and Indigenous-led organization whose purpose is to advance efforts for reconciliation with Indigenous peoples.*

National Diffuse Midline Glioma Awareness Day Act (Bill S-260). Senate 2<sup>nd</sup> Reading May 30, 2024. *Summary: This enactment designates the 17th day of May in each and every year as ‘National Diffuse Midline Glioma Awareness Day’.*

National Framework for a Guaranteed Livable Basic Income Act (Bill S-233). Senate 2<sup>nd</sup> Reading April 18, 2023. *Summary: This enactment requires the Minister of Finance to develop a national framework to provide all persons over the age of 17 in Canada with access to a guaranteed livable basic income. It also provides for reporting requirements with respect to the framework.*

National Framework on Advertising for Sports Betting Act (Bill S-269). Passed Senate November 5, 2024. *Summary: This enactment provides for the development of a national framework to regulate advertising for sports betting in Canada and to set national standards for prevention of risk for persons negatively impacted. It also provides for the Canadian Radio-television and Telecommunications Commission to review its regulations and policies to assess their adequacy and effectiveness in reducing the incidence of harms resulting from the proliferation of advertising of sports betting.*

National Framework on Cancers Linked to Firefighting Act (Bill C-224). Royal Assent June 22, 2023: S.C. 2023, 20. In force as set out in an Act. *Summary: This enactment provides for the development of a national framework designed to raise awareness of cancers linked to firefighting and to support improved access for firefighters to cancer prevention and treatment. The enactment also designates the month of January, in each year, as 'Firefighter Cancer Awareness Month'.*

National Framework on Fetal Alcohol Spectrum Disorder Act (Bill S-253). Senate 2<sup>nd</sup> Reading June 1, 2023. *Summary: This enactment provides for the development of a national framework designed to support Canadians with fetal alcohol spectrum disorder, their families and their caregivers.*

National Framework on Sickle Cell Disease Act (Bill S-280). Senate 2<sup>nd</sup> Reading June 4, 2024. *Summary: This enactment provides for the development of a national framework to support Canadians with sickle cell disease (also known as sickle cell anemia or drepanocytosis), their families and their caregivers.*

National Ribbon Skirt Day Act (Bill S-219). Royal Assent December 15, 2022: S.C. 2022, c. 16. In force as set out in the Act. *Summary: This enactment designates the 4th day of January in each and every year as 'National Ribbon Skirt Day'.*

National Security Review of Investments Modernization Act (Bill C-34). Royal Assent March 22, 2024: S.C. 2024, c. 4. The Act come into force on a day or days to be fixed by order of the Governor in Council – (SI/2024-32) September 3, 2024 is fixed as the day on which ss. 4(1,3, 4), 5, 6, 7(1.1), 8.1 to 11, 13, 14(2, 15 to 19), 20(3, 4), 21(4) 22 of the Act come into force. *Summary: This enactment amends the Investment Canada Act.*

National Strategy for Children and Youth Act (Bill S-282). Senate 2<sup>nd</sup> Reading June 4, 2024. *Summary: This enactment provides for the development of a national strategy to support children and youths in Canada.*

National Strategy for Eye Care Act (Bill C-284). Royal Assent November 7, 2024: S.C. 2024, c. 28. In force as set out in the Act. *Summary: This enactment provides for the development of a national strategy to support the prevention and treatment of eye disease to ensure better health outcomes for Canadians. It also designates the month of February as 'Age-Related Macular Degeneration Month'.*

National Strategy for the Prevention of Intimate Partner Violence Act (Bill S-249). Passed Senate November 26, 2024. *Summary: This enactment provides for the development of a national strategy for the prevention of intimate partner violence.*

National Strategy on Brain Injuries Act (C-277). Commons reported with amendments October 28, 2024. *Summary: This enactment provides for the development of a national strategy to support and improve brain injury awareness, prevention and treatment as well as the rehabilitation and recovery of persons living with a brain injury.*

National Strategy Respecting Environmental Racism and Environmental Justice Act (Bill C-226). Royal Assent June 20, 2024: S.C. 2024, c. 11. In force as

set out in the Act. *Summary: This enactment requires the Minister of the Environment, in consultation or cooperation with any interested persons, bodies, organizations or communities, to develop a national strategy to promote efforts across Canada to address the harm caused by environmental racism. It also provides for reporting requirements in relation to the strategy.*

National Thanadelthur Day Act (Bill S-274). Senate 2<sup>nd</sup> Reading November 7, 2024. *Summary: This enactment designates the 5th day of February in each year as “National Thanadelthur Day”.*

Nature Accountability Act (Bill C-73). Commons 1<sup>st</sup> Reading June 13, 2024. *Summary: This enactment imposes certain duties on the Minister of the Environment to promote transparency and accountability in relation to certain commitments that Canada has made under the Convention on Biological Diversity.*

Online Harms Act (Bill C-63). Commons 1<sup>st</sup> Reading February 26, 2024. *Summary: Part 1 of this enactment enacts the Online Harms Act, whose purpose is to, among other things, promote the online safety of persons in Canada, reduce harms caused to persons in Canada as a result of harmful content online and ensure that the operators of social media services in respect of which that Act applies are transparent and accountable with respect to their duties under that Act. Part 1 also makes consequential amendments to other Acts. Part 2 amends the Criminal Code and makes consequential amendments to other Acts. Part 3 amends the Canadian Human Rights Act to provide that it is a discriminatory practice to communicate or cause to be communicated hate speech by means of the Internet or any other means of telecommunication in a context in which the hate speech is likely to foment detestation or vilification of an individual or group of individuals on the basis of a prohibited ground of discrimination. It authorizes the Canadian Human Rights Commission to deal with complaints alleging that discriminatory practice and authorizes the Canadian Human Rights Tribunal to inquire into such complaints and order remedies. Part 4 amends An Act respecting the mandatory reporting of Internet child pornography by persons who provide an Internet service. Part 5 contains a coordinating amendment.*

Online News Act (Bill C-18). Royal Assent June 15, 2023: S.C. 2023, c. 23. In force as set out in the Act. *Summary: This enactment regulates digital news intermediaries to enhance fairness in the Canadian digital news marketplace and contribute to its sustainability. It establishes a framework through which digital news intermediary operators and news businesses may enter into agreements respecting news content that is made available by digital news intermediaries. The framework takes into account principles of freedom of expression and journalistic independence.*

Online Streaming Act (Bill C-11). Royal Assent April 27, 2023: S.C. 2023, c. 8. In force as set out in the Act; Subsections 40(2) to (4) come into force on a day to be fixed by order of the Governor in Council. *Summary: This enactment amends the Broadcasting Act. The enactment also makes related and consequential amendments to other Acts.*



- Pandemic Day Act (Bill S-209). Royal Assent May 12, 2024: S.C. 2024, c. 7. In force as set out in the Act. *Summary: This enactment designates March 11th in each and every year as ‘Pandemic Observance Day’.*
- Pandemic Prevention and Preparedness Act (Bill C-293). Passed Commons. Senate 1<sup>st</sup> Reading June 6, 2024. *Summary: This enactment enacts the Pandemic Prevention and Preparedness Act to require the Minister of Health to establish an advisory committee to review the response to the COVID-19 pandemic in Canada in order to reduce the risks associated with future pandemics and inform a pandemic prevention and preparedness plan. It also requires the Minister of Health to establish, in consultation with other ministers, a pandemic prevention and preparedness plan, which is to include information provided by those ministers. Finally, it amends the Department of Health Act to provide that the Minister of Health must appoint a national pandemic prevention and preparedness coordinator from among the officials of the Public Health Agency of Canada to coordinate the activities under the Pandemic Prevention and Preparedness Act.*
- Pension Protection Act (Bill C-228). Royal Assent April 27, 2023: S.C. 2023, c. 6. In force as set out in the Act. *Summary: This enactment amends the Bankruptcy and Insolvency Act and the Companies’ Creditors Arrangement Act to ensure that claims in respect of unfunded liabilities or solvency deficiencies of pension plans and claims relating to the cessation of an employer’s participation in group insurance plans are paid in priority in the event of bankruptcy proceedings. It also amends the Pension Benefits Standards Act, 1985 to provide that an employer may provide financial security in the form of insurance for any portion of the contributions that they are required to pay under subsections 9(1.1) and (1.2) of the Act, and to authorize the administrator of an underfunded pension plan, in certain situations, to transfer or permit the transfer of any part of the assets or liabilities of the pension plan to another pension plan. The amendments also provide for the tabling of an annual report respecting the solvency of pension plans.*
- Pharmacare Act (Bill C-64). Royal Assent October 10, 2024: S.C. 2024, c. 24. In force as set out in the Act. *Summary: This enactment sets out the principles that the Minister of Health is to consider when working towards the implementation of national universal pharmacare and provides the Minister with the power to make payments, in certain circumstances, in relation to the coverage of certain prescription drugs and related products. It also sets out certain powers and obligations of the Minister – including in relation to the preparation of a list to inform the development of a national formulary and in relation to the development of a national bulk purchasing strategy – and requires the Minister to publish a pan-Canadian strategy regarding the appropriate use of prescription drugs and related products. Finally, it provides for the establishment of a committee of experts to make certain recommendations.*
- Post-Secondary Institutions Bankruptcy Protection Act (Bill S-215). Senate 2<sup>nd</sup> Reading May 17, 2022. *Summary: This enactment provides for the development of a proposal for federal initiatives designed to ensure the financial*

*stability of post-secondary institutions. It also amends the Bankruptcy and Insolvency Act and the Companies' Creditors Arrangement Act to exclude post-secondary educational institutions from the definitions of corporation and company under those Acts, respectively.*

Preserving Provincial Representation in the House of Commons Act (C-14).

Royal Assent June 23, 2022: S.C. 2022, c. 6. In force as set out in the Act. *Summary: This enactment amends section 51 of the Constitution Act, 1867 to provide that, when the number of members of the House of Commons and the representation of the provinces in that House are readjusted on the completion of each decennial census, a province will not have fewer members assigned to it than were assigned during the 43rd Parliament. It also includes transitional measures providing for the application of that amendment to the readjustment of electoral boundaries under the Electoral Boundaries Readjustment Act following the 2021 decennial census.*

Protecting Canada's Natural Wonders Act (Bill S-14). Passed Senate. Commons

1<sup>st</sup> Reading February 27, 2024. *Summary: This enactment amends the Canada National Parks Act to, among other things, (a) broaden and clarify offences in relation to the discharge or deposit of substances in a national park or national park reserve; (b) expand the boundaries of seven national parks and one national park reserve; (c) establish the Akami-Uapishk-KakKasuak-Mealy Mountains National Park Reserve of Canada and enact provisions for its operation and administration; and (d) change the name of 'Gwaii Haanas National Park Reserve of Canada' to 'Gwaii Haanas National Park Reserve and Haida Heritage Site'. The enactment also amends the Canada National Marine Conservation Areas Act to establish the Tallurutiup Imanga National Marine Conservation Area and the Rouge National Urban Park Act to broaden and clarify offences in relation to the discharge or deposit of substances in that Park and makes consequential amendments to the National Parks of Canada Fishing Regulations.*

Protecting Young Persons from Exposure to Pornography Act (Bill S-210).

Passed Senate. Commons reported without amendment June 7, 2024. *Summary: This enactment makes it an offence for organizations to make sexually explicit material available to young persons on the Internet. It also enables a designated enforcement authority to take steps to prevent sexually explicit material from being made available to young persons on the Internet in Canada.*

Providing Alternatives to Isolation and Ensuring Oversight and Remedies in the

Correctional System Act (Tona's Law) (Bill S-230). Senate reported without amendment October 22, 2024. *Summary: This enactment amends the Corrections and Conditional Release Act to, among other things*

Public Complaints and Review Commission Act (Bill C-20). Passed Commons.

Senate 2<sup>nd</sup> Reading June 20, 2024. *Summary: This enactment, among other things, (a) establishes, as a replacement of the Civilian Review and Complaints Commission for the Royal Canadian Mounted Police, an independent body, called the Public Complaints and Review Commission, to (i) review and investigate complaints concerning the conduct and level of service of*

*Royal Canadian Mounted Police and Canada Border Services Agency personnel, and (ii) conduct reviews of specified activities of the Royal Canadian Mounted Police and the Canada Border Services Agency; (b) authorizes the Chairperson of the Public Complaints and Review Commission to recommend the initiation of disciplinary processes or the imposition of disciplinary measures in relation to individuals who have been the subject of complaints; (c) amends the Canada Border Services Agency Act to provide for the investigation of serious incidents involving officers and employees of the Canada Border Services Agency; (d) amends the English version of federal statutes and orders, regulations and other instruments to replace references to the 'Force' with references to 'RCMP'; and (e) makes consequential amendments to other Acts.*

Public Sector Integrity Act (Bill C-290). Passed Commons. Senate 1<sup>st</sup> Reading February 6, 2024. *Summary: This enactment amends the Public Servants Disclosure Protection Act to, among other things, expand the application of the Act to additional categories of public servants, permit that a protected disclosure be made to an officer within the portion of the public sector in which the public servant is employed, extend the period during which a reprisal complaint may be filed and add a duty to provide support to public servants.*

Recognition of Certain Métis Governments in Alberta, Ontario and Saskatchewan and Métis Self-Government Act (Bill C-58). Commons reported with amendments February 8, 2024. *Summary: This enactment provides for the recognition of certain Métis governments in Alberta, Ontario and Saskatchewan and provides a framework for the implementation of treaties entered into by those Métis governments and the Government of Canada. Finally, it makes consequential amendments to other Acts.*

Registered Charity Board Diversity Data Collection Act (Bill S-279). Senate 2<sup>nd</sup> Reading May 30, 2024. *Summary: This enactment amends the Income Tax Act to require that registered charities provide certain demographic data concerning their officers to the Minister of National Revenue, who must compile that information for reporting purposes.*

Rental Housing Benefit Act (enactment)...See...Cost of Living Relief Act, No. 2 (Targeted Support for Households) (Bill C-31) S.C. 2022, c. 14.

Reuniting Families Act (Bill C-242). Royal Assent June 22, 2023: S.C. 2023, c. 21. In force as set out in the Act. *Summary: This enactment amends the Immigration and Refugee Protection Act to allow a parent or grandparent who applies for a temporary resident visa as a visitor to purchase private health insurance outside Canada and to stay in Canada for a period of five years. It also requires the Minister of Citizenship and Immigration to prepare and table a report on reducing the minimum income requirement that the child or grandchild must meet in order for the visiting parent or grandparent to be able to enter and remain in Canada for an extended period.*

Select Luxury Items Tax Act (enactment)...See...Budget Implementation Act, 2022, No. 1 (Bill C-19) S.C. 2022, c. 10.

Self-Government Treaty Recognizing the Whitecap Dakota Nation / Wapaha Ska Dakota Oyate Act (Bill C-51). Royal Assent June 22, 2023: S.C. 2023, c. 22.

The Act, other than section 16, comes into force on a day to be fixed by order of the Governor in Council – (SI/2023-55) September 1, 2023 is fixed as the day on which the Act comes into force, other than section 16, which came into force on assent. *Summary: This enactment gives effect to the treaty entitled ‘A Self-Government Treaty Recognizing the Whitecap Dakota Nation / Wapaha Ska Dakota Oyate’ and makes consequential amendments to other Acts.*

Stopping Internet Sexual Exploitation Act (C-270). Commons reported without amendment November 19, 2024. *Summary: This enactment amends the Criminal Code to prohibit a person from making, distributing or advertising pornographic material for commercial purposes without having first ascertained that, at the time the material was made, each person whose image is depicted in the material was 18 years of age or older and gave their express consent to their image being depicted.*

Strengthening Environmental Protection for a Healthier Canada Act (Bill S-5). Royal Assent June 13, 2023: S.C. 2023, c. 12. In force as set out in the Act; sections 64, 67(2), (5) and (6) come into force on a day to be fixed by order of the Governor in Council. *Summary: This enactment amends the Canadian Environmental Protection Act, 1999. The enactment also makes related amendments to the Food and Drugs Act to enable the assessment and management of risks to the environment associated with foods, drugs, cosmetics and devices by, among other things. Finally, the enactment repeals the Perfluorooctane Sulfonate Virtual Elimination Act.*

Strengthening the Port System and Railway Safety in Canada Act (Bill C-33). Commons reported with amendments February 7, 2024. *Summary: This enactment amends several Acts in order to strengthen the port system and railway safety in Canada. The enactment amends the Customs Act to require that, on request, any person in possession or control of imported goods make those goods available for examination in accordance with regulations and deliver those goods, or cause them to be delivered, to a secure area that meets the requirements set out in regulation.*

**Tax Break for All Canadians Act (Bill C-78). Passed Commons. Senate reported without amendment December 5, 2024. *Summary: This enactment amends the Excise Tax Act in order to implement a temporary GST/HST holiday between December 14, 2024 and February 15, 2025 inclusively in respect of certain taxable supplies.***

Ukrainian Heritage Month Act (Bill S-276). Passed Senate November 19, 2024. *Summary: This enactment designates the month of September as “Ukrainian Heritage Month”.*

Underused Housing Tax Act (enactment)...See...Economic and Fiscal Update Implementation Act, 2021 (Bill C-8) S.C. 2022, c. 5.

Use of French in Federally Regulated Private Businesses Act (enactment)...See...An Act for the Substantive Equality of Canada’s Official Languages (Bill C-13) S.C. 2023, c. 15.

Véronique Barbe Act (Bill S-238). Senate 2<sup>nd</sup> Reading November 3, 2022. *Summary: This enactment amends provisions of the Criminal Code in order to*

*provide for the possibility of ordering an accused, defendant, offender or other person to refrain from publishing, distributing, transmitting or making available on the Internet any information concerning victims and, in some cases, other persons. It also amends the Canadian Victims Bill of Rights by adding a right to have reasonable measures taken in order to prohibit an offender from publishing, distributing, transmitting or making available on the Internet any information concerning victims.*

Wasted Food Reduction and Recovery Act (Bill C-360). Commons 1<sup>st</sup> Reading October 26, 2023. *Summary: This Act amends various other Acts.*

## **THE LAW OF DEMOCRATIC GOVERNING – PRINCIPLES**
