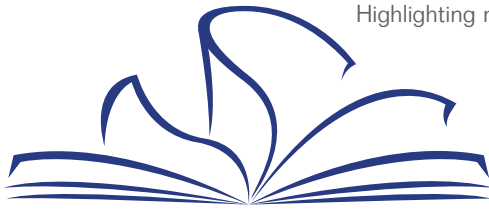

Highlights:

In the coming year, we plan reconsolidations for selected titles of the Case Law Digests. We plan to reissue the following titles:

Motor Vehicles (approx. 3 volumes)

Estates and Trusts (approx. 5 volumes)

Municipal Law (approx. 15 volumes)

It is necessary to reissue the Consolidated Table of Cases because the supplements have become unmanageably large. The reissue is expected to comprise approximately 20 volumes.

While we endeavour to provide you with the most accurate prices and publishing dates, it is impossible at this time to state with absolute certainty the number of volumes, month of publication, and price. All prices are estimates and may change. We can, however, provide you with an outline of the 2012 program as it is currently planned, and we will keep you informed of any variation as the year unfolds.

Components

- **Main Work:** We plan to reissue three titles (see *Highlights* above), consisting of approximately 23 volumes, in September and December of the coming year.
