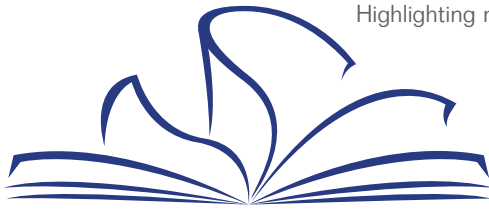

Highlights:

The only major reconsolidations planned for 2013 will be for the Case Law Digest component of the Abridgment and the Rules volumes of the Canadian Statute Citations. We plan to reissue the following titles of the Case Law Digest:

- Debtor and creditor (3 volumes)
- Financial Institutions /Guarantee and indemnity (1 volume)
- Public law (6 volumes)
- Commercial law (3 volumes)
- Communications law /Conflict of Laws (2 volumes)
- Intellectual Property (6 volumes)
- Natural Resources (2 volumes)
- Pensions (2 volumes)

While we endeavour to provide you with the most accurate prices and publishing dates, it is impossible at this time to state with absolute certainty the number of volumes, month of publication, and price. All prices are estimates and may change. We can, however, provide you with an outline of the 2013 program as it is currently planned, and we will keep you informed of any variation as the year unfolds.
