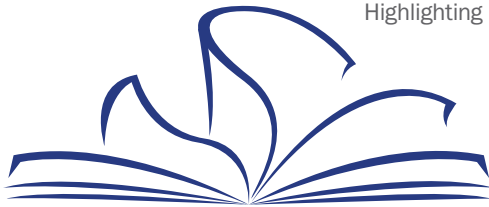

The only major reconsolidations planned for 2015 will be for the Case Law Digest component of the Abridgment, and the Canada Statute Citations, Canada/International volumes.

We plan to reissue only one title of the Case Law Digests: **Civil Practice and Procedure**. We expect the reissue to comprise 28 volumes.

There have been significant changes to the Rules in several jurisdictions. We are updating the title to reflect those changes. The value of the Civil Practice and Procedure title will be significantly enhanced by this process.

The reconsolidation of the Canada/International volumes of the Canada Statute Citations is expected to comprise 24 volumes.

While we endeavour to provide you with the most accurate prices and publishing dates, it is impossible at this time to state with absolute certainty the number of volumes, month of publication, and price. All prices are
